3 **Motion appointing Ali Jamalian, Adam Hayes, Apollo Wallace (residency requirement**
4 **waived), Drakari Donaldson, David Nogales Talley (residency requirement waived),**
5 **Shay Aaron Gilmore, and Antoinette Mobley, terms ending December 3, 2024, to the**
6 **Cannabis Oversight Committee.**

8 MOVED, That the Board of Supervisors of the City and County of San Francisco does
9 hereby appoint the hereinafter designated person(s) to serve as member(s) of the Cannabis
10 Oversight Committee, pursuant to the provisions of the San Francisco Administrative Code,
11 Chapter 5, Article XXXVIII, for the terms specified:

12 Ali Jamalian, seat 8, succeeding themselves, must be held by an Owner of a Cannabis
13 Business permitted through the Equity Program, for the unexpired portion of a two-year term
14 ending December 3, 2024;

15 Adam Hayes, seat 9, succeeding Aaron Flynn, term expired, must be held by the
16 operator of a Cannabis cultivation, manufacturing, or distribution business with fewer than 20
17 employees at the time of appointment, for the unexpired portion of a two-year term ending
18 December 3, 2024;

19 Apollo Wallace (residency requirement waived), seat 11, succeeding Doug Bloch, term
20 expired, must be held by a representative of organized labor who works with the Cannabis
21 delivery service labor force, for the unexpired portion of a two-year term ending December 3,
22 2024;

23 Drakari Donaldson, seat 12, succeeding Shawn Richard, term expired, must be held by
24 an owner of a storefront Cannabis retailer, for the unexpired portion of a two-year term ending
25 December 3, 2024;

1 David Nogales Talley (residency requirement waived), seat 13, succeeding Leah 'Nina
2 Parks' Weitz, term expired, must be held by a person who, at the time of the appointment, is
3 an Equity Applicant, as that term is defined in Police Code, Subsection 1604(b), for the
4 unexpired portion of a two-year term ending December 3, 2024;

5 Shay Aaron Gilmore, seat 14, succeeding Brendan Hallinan, term expired, must be
6 held by a person with demonstrated subject matter expertise on the State of California's
7 Cannabis laws and regulations, for the unexpired portion of a two-year term ending December
8 3, 2024;

9 Antoinette Mobley, seat 16, succeeding Sara Payan, term expired, must be held by a
10 person who has been a Medicinal Cannabis patient or Medicinal Cannabis consumer for at
11 least five years, with an extensive history advocating for Medicinal Cannabis patients or
12 involvement in implementing and running a Cannabis compassionate use program in
13 compliance with the Compassionate Use Act of 1996, for the unexpired portion of a two-year
14 term ending December 3, 2024; and, be it

15 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 16 1. The membership of the Cannabis Oversight Committee has a goal to be representative
17 of the diversity of the City and County of San Francisco.
- 18 2. Applicants Apollo Wallace and David Nogales Talley, who are not residents of San
19 Francisco, are persons with experience that uniquely qualifies them to serve on the
20 Cannabis Oversight Committee.
- 21 3. The Cannabis Oversight Committee has attempted to fill the positions, for which Apollo
22 Wallace and David Nogales Talley were nominated, with individuals who are City
23 residents and who have the specific experience, skills, and qualifications, but has been
24 unable to do so at this time. The Rules Committee has certified that Apollo Wallace
25 and David Nogales Talley are qualified to serve on the Cannabis Oversight Committee.

1 4. After exercising due diligence, the Board of Supervisors concludes that there are no
2 other possible representatives who are residents of San Francisco, who have the
3 specific experience, skills, or qualifications possessed by these applicants, and who
4 are willing to serve on the Cannabis Oversight Committee at this time; and, be it
5 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
6 for Apollo Wallace and David Nogales Talley, as is allowed in cases where no qualified City
7 residents who are willing to serve can be found, pursuant to Charter, Section 4.101(a)(2), that
8 otherwise requires person(s) appointed to boards, commissions, and advisory bodies
9 established by legislative act of the Board of Supervisors to be resident(s) of the City and
10 County of San Francisco.
