3 **Resolution supporting the “All In” campaign to contribute to the City’s efforts to**
4 **reduce homelessness by welcoming homes and services in every District.**

6 WHEREAS, Homelessness is a public health issue that impacts the entire City of San
7 Francisco and cannot be solved by a single sector alone; and

8 WHEREAS, According to the 2019 Point In Time (PIT) Count, there are people
9 experiencing homelessness in every San Francisco Supervisorial District, making
10 homelessness a city-wide crisis that requires a city-wide response; and

11 WHEREAS, Every District must play a role in reducing homelessness; and

12 WHEREAS, The All In campaign is a multi-sector, community-driven effort to promote
13 evidence-based solutions to homelessness, particularly homes and services, across San
14 Francisco; and

15 WHEREAS, The All In campaign is comprised of over 90 organizations representing
16 non-profit service providers, business, labor, healthcare, tech, and faith organizations; and

17 WHEREAS, Thousands of San Franciscans, representing every District in the City,
18 have declared their support for the All In campaign, expressing their willingness to welcome
19 homes and services in their neighborhoods; and

20 WHEREAS, In 2019, the Department of Homelessness and Supportive Housing
21 developed a strategic framework, which, among other priorities, calls for (1) an end to family
22 homelessness by 2022; (2) 50% reduction in chronic homelessness by 2022; and (3) 50%
23 reduction in youth homelessness by 2022; and

24 WHEREAS, The All In campaign seeks to support the City’s strategic framework by
25 securing homes and services for 1,100 people experiencing homelessness by 2022; and

1 WHEREAS, The increase in unsheltered homelessness in San Francisco reported in
2 the 2019 PIT Count calls for even greater urgency in identifying potential housing
3 opportunities; and

4 WHEREAS, Current policies and practices for securing homes and services for people
5 experiencing homelessness can be lengthy and cumbersome, often taking many months or
6 sometimes longer, to move individuals off the streets or from shelter into a stable home; and

7 WHEREAS, The All In campaign recognizes that solutions must be customized to
8 individual circumstances, with some people needing permanent supportive housing, and
9 others needing rapid rehousing, problem solving, or other interventions; and

10 WHEREAS, The City therefore needs a flexible approach to address the varied needs
11 of people experiencing homelessness; and

12 WHEREAS, One of the benefits of providing homes and services in each District is that
13 it allows for greater flexibility in securing the appropriate interventions needed for the different
14 needs of people experiencing homelessness; and

15 WHEREAS, Through the Moving On Initiative, the City has already successfully utilized
16 a scattered site housing approach (i.e., identifying and securing individual units in buildings
17 spread throughout the City); and

18 WHEREAS, The All In campaign plans to use a combination of scattered site housing
19 and rehabilitation or preservation of affordable housing to secure homes and supportive
20 services for 1,100 people; now, therefore, be it

21 RESOLVED, That the Board of Supervisors supports the All In campaign's call for
22 every District to contribute to the City's efforts to reduce homelessness by welcoming homes
23 and services in every District; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors wholeheartedly supports the All
2 In campaign and its goal of securing homes and services for 1,100 people across San
3 Francisco.


