6 OPEN AFTER 10:00 PM INSTEAD OF THE CURRENT CONDITION NO. 2 IMPOSED
7 ON SAID LICENSE THAT RESTRICTS THE SALE OF ALCOHOLIC BEVERAGES
8 BETWEEN THE HOURS OF 8:00 AM AND 10:00 PM ONLY EACH DAY OF THE
9 WEEK AND DETERMINING THAT IT IS NOT JUSTIFIED UNDER THE PROVISIONS
10 OF SECTION 23803 OF THE CALIFORNIA BUSINESS AND PROFESSIONS CODE.

12 WHEREAS, Weldezghi, Seray Gebresillasi dba "Haz San Francisco Liquor"
13 located at 1401 Polk Street, is seeking the removal of Condition # 2 on his Type 21
14 Conditional Alcoholic Beverage license; and,

15 WHEREAS, The Police Department recommends the disapproval of the removal
16 of Condition #2; now, therefore, be it

17 RESOLVED, That the Board of Supervisors of the City and County of San
18 Francisco hereby disapproves the removal of Condition #2 on the Conditional Alcoholic
19 Beverage license for Weldezghi, Zeray Gebresillasi dba "Haz San Francisco Liquor"
20 located at 1401 Polk Street and determines that it is not justified under the provisions of
21 Section 23803 of the California Business and Professions Code.


