15 WHEREAS, The facility studies will position the Library to favorably compete
16 for Proposition 14 State Library Construction Funds and facilitate branch renovation
17 planning and construction in anticipation of the passage of the Branch Library
18 Improvement Bond in November, and

19 WHEREAS, The Friends & Foundation of the San Francisco Public Library has
20 committed itself to financially assisting the City and the Library to realize the vision of
21 first class neighborhood Branch Libraries through its support of the Branch Library
22 Improvement Bond Measure and through other generous gifts it provides the Library, and


WHEREAS, it is in the public's interest to encourage and support the public/private partnership between the Library and the Friends & Foundation, now therefore be it




