

1 [Apply-Accept-Expend State Grants]

2 AUTHORIZING THE DEPARTMENT OF RECREATION AND PARK TO APPLY, ACCEPT
3 AND EXPEND GRANTS IN THE TOTAL AMOUNT OF \$3,644,500 FROM THE STATE
4 GENERAL FUND FOR SUNNYSIDE (MONTEREY) CONSERVATORY, JOHN MUIR WAY
5 FISHING PIER AT LAKE MERCED, AND PALACE OF FINE ARTS.

7 WHEREAS, The Legislature and Governor of the State of California
8 have approved grants of \$295,500 to stabilize and restore Sunnyside
9 (Monterey) Conservatory; \$394,000 for the restoration of the John
10 Muir Way fishing pier at Lake Merced; \$2,955,000 for the restoration
11 and rehabilitation of structures and landscape at the Palace of Fine
12 Arts; for a total of \$3,644,500; and,

13 WHEREAS, The State Department of Parks and Recreation has been
14 delegated the responsibility for the administration of these grant
15 projects, setting up necessary procedures; and,

16 WHEREAS, Said procedures established by the State Department of
17 Parks and Recreation require the applicant to certify by resolution
18 the approval of applications for the above projects before submission
19 of said applications to the State; and,

20 WHEREAS, The applicant will enter into an agreement with the
21 State of California for the subject projects; and,

22 WHEREAS, The Department proposes to maximize use of available
23 grant funds on program expenditures by not including indirect costs
24 in the grant budget; now, therefore, be it


1 RESOLVED, That the City and County of San Francisco Board of
2 Supervisors hereby:

- 3 1. Approves the application, acceptance, and expenditure of
4 \$295,500 to stabilize and restore Sunnyside (Monterey)
5 Conservatory; \$394,000 for the restoration of the John Muir Way
6 fishing pier at Lake Merced; \$2,995,000 for the restoration and
7 rehabilitation of structures and landscape at the Palace of Fine
8 Arts; for a total of \$3,644,500;
- 9 2. Certifies that the City and County of San Francisco Recreation
10 and Park Department is in accordance with the general provisions
11 of the agreement with the State of California;
- 12 3. Certifies that the City and County of San Francisco has
13 sufficient funds to operate and maintain the projects funded
14 under this program;
- 15 4. Certifies that the Recreation and Park Department has reviewed
16 and understands the General Provisions contained in the
17 State/local agreement shown in the Procedural Guide;
- 18 5. Appoints the General Manager or Acting General Manager as agent
19 of the Recreation and Park Department to conduct all
20 negotiations, execute and submit all documents, including but
21 not limited to applications, agreements, payment requests and so
22 on, which may be necessary for the completion of the
23 aforementioned projects; and
- 24 6. Waives inclusion of indirect costs in the grant budget.
