

1 [Urging Contributions to Ameliorate the Effects of Slavery]

3 **Resolution urging the City Administrator and City Controller to encourage city**  
4 **contractors that have participated and/or profited from slave trades to make voluntary**  
5 **contributions to ameliorate the legacy of slavery.**

7 WHEREAS, Many San Francisco residents are descendants of people subjected to  
8 slavery, and the impacts of slavery in the United States continues to have a harmful impact on  
9 the experiences and outcomes of Black and African American people in San Francisco; and

10 WHEREAS, People forced into slavery were dehumanized, snatched from their  
11 families, and coerced into performing labor without appropriate compensation or benefits, and  
12 were defined and insured as private property, and used as collateral for insurance policies,  
13 loans and other transactions; and

14 WHEREAS, In 2006, the Board of Supervisors passed Ordinance No. 275-06, Slavery  
15 Era Disclosure, requiring city contractors providing insurance and insurance services, financial  
16 services, or textiles to the City to disclose any participation in the slave trade; and

17 WHEREAS, Ordinance No. 275-06 also created an account, through the City  
18 Controller’s office, for contractors subject to the Ordinance to make voluntary contributions,  
19 and requiring that monies donated to this account be used to fund economic development and  
20 educational initiatives designed to ameliorate the effects of slavery upon the residents of San  
21 Francisco; and

22 WHEREAS, Insurance policies from the American slavery era documented insurance  
23 coverage to slaveholders for damage to or death of people subjected to slavery, and financial  
24 services firms bought or sold people subjected to slavery, provided loans to purchase people  
25 subjected to slavery, and profited from the trade of people subjected to slavery; and

1           WHEREAS, In filing an affidavit in compliance with this Ordinance, U.S. Bank has  
2 identified relevant records that its predecessor companies participated in and benefited from  
3 the slave trade; and

4           WHEREAS, Ordinance No. 275-06 requires that the Office of the City Administrator  
5 encourage all contractors subject to the ordinance to make voluntary contributions to an  
6 account to be used to ameliorate the legacy of the slavery era on persons subjected to slavery  
7 and their descendants; and

8           WHEREAS, In February of 2015, the Office of the City Administrator sent letters  
9 requesting voluntary contributions from all City vendors covered by Ordinance No. 275-06,  
10 and no responses were received; and

11           WHEREAS, In August 2020, the San Francisco Board of Supervisors passed  
12 Resolution No. 376-20 supporting a reparations plan that will comprehensively address the  
13 inequities that exist in the African American community as a result of slavery's legacy of  
14 systemic oppression and creation of an advisory committee for the African American  
15 community; and

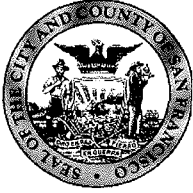
16           WHEREAS, In December 2020, Ordinance No. 259-20 officially established the African  
17 American Reparations Advisory Committee (AARAC) to advise the Board of Supervisors, the  
18 Mayor, the Human Rights Commission, and the public regarding the development, adoption,  
19 and implementation of a San Francisco Reparations Plan that determines the scope and  
20 eligibility for a citywide reparations program, examines current structural discrimination within  
21 San Francisco, and proposes institutional reforms to guard against the need for future  
22 redress; and

23           WHEREAS, The AARAC began convening in June 2021, and released the first draft of  
24 the San Francisco Reparations Plan in December 2022; this first draft was heard at the  
25 Committee of the Whole on March 14, 2023, at the San Francisco Board of Supervisors; and

1           WHEREAS, On June 30, 2023, the AARAC released the final San Francisco  
2           Reparations Plan 2023, prepared by the Human Rights Commission and a digital copy was  
3           sent to the Board of Supervisors; the Board of Supervisors will hear the final report at the  
4           Committee of the Whole scheduled for the September 19, 2023, Board of Supervisors  
5           meeting; and

6           WHEREAS, Requesting voluntary contributions from all City vendors covered by  
7           Ordinance No. 275-06, that have or have had their predecessor firms profited or participated  
8           in slavery, directly supports San Francisco's reparations efforts on the long historical impacts  
9           of slavery; now, therefore, be it

10          RESOLVED That the Board of Supervisors of the City and County of San Francisco  
11          urges the Office of the City Administrator and City Controller to send letters to all City vendors  
12          covered by Ordinance No. 275-06 to encourage them to make voluntary contributions to  
13          ameliorate the effects of slavery as part of San Francisco's reparations efforts.
