2 provision in her current contract for a \$375,000 severance package]

3 **Resolution urging San Francisco Unified School District Superintendent Arlene**
4 **Ackerman to forego the provision in her current contract for a \$375,000 severance**
5 **package.**

7 WHEREAS, The San Francisco Unified School District (SFUSD) faced a \$22.5 million
8 budget deficit for the 2005-06 school year that resulted in teacher layoffs, the closure of five
9 schools and the anticipation of future school closures; and,

10 WHEREAS, The SFUSD's declining enrollment numbers will cause equally damaging
11 budget deficits in future school years; and,

12 WHEREAS, Approximately 53 percent of the 57,000 students in the SFUSD live in low-
13 income households that qualify them for free or reduced-price lunches; and,

14 WHEREAS, Many SFUSD schools continue to under-perform dramatically, with Balboa
15 High School students, for example, scoring in the 10th percentile on the English portion of the
16 2004-05 California Standards Test; and,

17 WHEREAS, Despite recent improvements, only 45 percent of SFUSD students perform
18 at grade level in English and only 46 percent do so in math; and,

19 WHEREAS, Superintendent Ackerman's recent contract includes a provision that
20 would give her a \$375,000 severance package if she leaves the SFUSD because of
21 "compatibility" issues with the Board of Education; and,

22 WHEREAS, Superintendent Ackerman's contract also included a \$26,000 raise to her
23 annual salary and a raise in her monthly housing allowance from \$1,200 to \$2,000; and,

24 WHEREAS, Superintendent Ackerman's annual salary is \$250,000, which is 30
25 percent higher than the average salary for a superintendent in California; and,

1 WHEREAS, Superintendent Ackerman announced her resignation and invoked the
2 "compatibility clause" in her contract on September 6, 2005; and,

3 WHEREAS, The beginning salary for a teacher in the SFUSD ranges from \$39,653 to
4 \$41,219; and,

5 WHEREAS, Superintendent Ackerman's \$375,000 severance package could pay for
6 almost 10 teachers for one school year; and,

7 WHEREAS, A lawsuit filed by a student, parent, teacher and a taxpayer alleged that
8 Superintendent Ackerman's contract was approved by the Board of Education in violation of
9 the State's Education Code; and,

10 WHEREAS, A District parent and Parent Advocate circulated a petition signed by
11 concerned parents asking Superintendent Ackerman to put the District's children first by
12 rejecting the \$375,000 severance package; now, therefore, be it

13 RESOLVED, That the City and County of San Francisco urges Superintendent Arlene
14 Ackerman to forego the \$375,000 severance package in her current contract; and be it

15 FURTHER RESOLVED, That the Clerk of the Board of Supervisors shall send a copy
16 of this resolution to the Board of Education, San Francisco Unified School District, 555
17 Franklin Street, San Francisco, CA, 94102; and be it

18 FURTHER RESOLVED, That the Clerk of the Board of Supervisors shall send a copy






