8	Be it ordained by the People of the City and County of San Francisco:	
9	Section 1. The San Francisco Administrative Code is hereby amended by adding	
10	Article XXIV, to read as follows:	
11	Article XXIV CITY HALL PRESERVATION ADVISORY COMMISSION	
12	SEC. 5.240. ESTABLISHMENT AND PURPOSE.	
13	There shall be established a City Hall Preservation Advisory Commission for the purpose	<u>of</u>
14	ensuring that City Hall is maintained and preserved in a manner befitting its historic and architec	<u>tura</u>
15	significance. San Francisco's City Hall is a national landmark and a valued legacy to the people	<u>of</u>
16	this city. After its completion in 1915, it suffered a process of gradual alteration and degradation	untii
17	the Loma Prieta earthquake of 1989 forced its temporary closure. Inadequate repair and mainten	ance
18	contributed to the decline. Between 1989 and 2000, in addition to earthquake retrofitting, the Cit	<u>y did</u>
19	extensive work to repair and refurbish City Hall and to reverse many alterations which had	
20	compromised the building's historical integrity. This Commission is intended to be an advisory be	<u>ədy</u>
21	responsible for ensuring that the building's historical character and beauty are preserved hencefor	<u>rth</u>
22	and that the facilities are maintained according to the highest standard and not allowed to fall into	<u>o</u>
23	<u>disrepair.</u>

25	SEC. 5.241. MEMBERSHIP AND ORGANIZATION.	

1	(a) The Commission shall consist of five members appointed by the Mayor, and confirmed by a
2	majority vote of the Board of Supervisors and serving at his or her pleasure. The Mayor shall
3	designate three of his or her initial appointments to serve for two-year terms and two for four-year
4	terms. Thereafter, all members shall serve for four-year terms. The terms are to commence on the date
5	of the first meeting of the Commission, which may not occur until all five members have been
6	appointed.
7	(b) At least one member of the Commission shall have documented expertise in the area of
8	building maintenance and repair. At least one member shall have documented expertise in the area of
9	historic building preservation. At least one member shall have documented expertise in the history of
10	<u>City Hall.</u>
11	(c) Vacancies shall be filled by the Mayor, and confirmed by the Board, for the remainder of
12	the term. The Commission shall, at its initial meeting and annually thereafter, elect one of its members
13	to chair the Commission.
14	(d) Services of the members of the Commission shall be voluntary and members will serve
15	without compensation.
16	(e) The Director of Administrative Services, or his/her designee, shall attend meetings of the
17	Commission and provide staff support.
18	SEC 5.242. DUTIES OF THE COMMISSION.
19	The Commission shall have the following duties:
20	(a) Conduct meetings as necessary, but not less than once monthly;
21	(b) Conduct public hearings and advise the Mayor, the Board of Supervisors, the Planning
22	Commission, the Landmarks Preservation Advisory Board, and the Director of Administrative Services
23	as appropriate, on the following matters:
24	(1) budgetary issues related to the operation, maintenance, repair and preservation of
25	City Hall;

1	(2) requests for use, modification, or alteration of City Hall facilities;
2	(3) maintenance and operation of City Hall consistent with its stature and dignity as a
3	national landmark and as the seat of City government;
4	(4) displays of historical significance in the South Light Court and in other areas of
5	City Hall;
6	(5) improvements and acquisitions which would enhance the historical character of
7	City Hall;
8	(6) any other matter affecting the use, operation or maintenance of City Hall.
9	(c) Solicit donations to the City for the benefit of City Hall; both of a financial nature as well as
10	of artworks and historically significant artifacts which would be appropriate for display. Any such
11	gifts shall be subject to the applicable approval and acceptance processes as set forth in the Charter.
12	(d) Keep records of acquisitions, donations, modifications, major repairs and Commission
13	recommendations and compile an annual report to be submitted to the Mayor and the Board of
14	Supervisors.
15	SEC. 5.243. REFERRAL TO THE COMMISSION.
16	(a) The Director of Administrative Services shall promptly notify the Commission and provide
17	opportunity for comment before he or she adopts policies or procedures affecting the operation or
18	maintenance of City Hall, and before he or she makes or approves alterations to City Hall.
19	(b) The secretary of the Landmarks Preservation Advisory Board shall notify the Commission
20	within ten days of receipt of an application for a Certificate of Appropriateness affecting City Hall.
21	The secretary shall provide all relevant information, including the date and time of the hearing. Any
22	recommendations which the Commission makes shall be included in the record of the application by the
23	Landmarks Preservation Advisory Board.
24	SEC. 5.244. STANDARDS FOR PRESERVATION AND RESTORATION.
25	

1	In carrying out its duties, the Commission shall be guided by accepted standards for
2	restoration, preservation, and maintenance of historic structures, including, where applicable and
3	feasible, standards for historic preservation, maintenance, recordation, and documentation of
4	landmarks promulgated by the United States Department of the Interior or its successor.
5
