WHEREAS, On April 17, 2012, by Resolution No. 12-0085, the Airport Commission awarded the International Terminal and Terminal 3 Newsstands / Café Lease No. 12-0085 ("Lease"), under which WDFG North America, LLC ("WDFG") currently operates four newsstands and a café at San Francisco International Airport (the "Airport"); and

WHEREAS, By Resolution No. 102-13 adopted on April 9, 2013, this Board of Supervisors approved the Lease, a copy of which is on file with the Clerk of the Board in File No. 121192; and

WHEREAS, In order to accommodate the Airport's planned passenger screening checkpoint expansion project in the International Terminal, the Airport and WDFG desire to amend the Lease to relocate two of WDFG's newsstands and its café, and to close another of its newsstands; and

WHEREAS, On February 21, 2017, by Resolution No. 17-0033, the Airport Commission approved Amendment No. 1 to the Lease; now, therefore, be it

RESOLVED, That the Board of Supervisors approves Amendment No. 1 to the Lease, which (1) reduces the total square footage of the WDFG leasehold space by approximately 11%, (2) reimburses WDFG for unamortized construction costs in an amount not to exceed

\$937,961.00 in the form of a rental credit, and (3) reduces the minimum annual guarantee portion of the rent and the annual promotional charge in proportion to the net reduction in the square footage of the premises; and, be it

FURTHER RESOLVED, That within thirty (30) days of the amendment being fully executed by all parties, the Airport Commission shall provide the final amendment to the Clerk of the Board for inclusion into the official file.
