

1 [Cellular Antenna Community Meeting Notification]
2 URGING THE PLANNING DEPARTMENT TO ESTABLISH PROCEDURES FOR CELL SITE
3 COMMUNITY MEETING NOTIFICATION IN APPROPRIATE LANGUAGES.

5 WHEREAS, The Planning Code requires conditional use
6 authorization to place major cellular antenna sites in San Francisco;
7 and,

8 WHEREAS, In addition to Planning Code regulations, cellular
9 antenna placement in San Francisco is governed by The City's Wireless
10 Telecommunications Services Facilities Siting Guidelines adopted
11 August 15, 1996; and

12 WHEREAS, These guidelines classify structures with a residential
13 component as less desirable for placement of cellular antennas; and,

14 WHEREAS, The Planning Department recommends that project
15 sponsors hold community meetings when placing an antenna at a site
16 classified as less desirable; and,

17 WHEREAS, The purpose of such meetings is to give residents a
18 meaningful opportunity to express their sentiments about the location
19 of such a project in their neighborhood; and

20 WHEREAS, In some instances, a great deal of residents do not
21 comprehend the English-only notices currently posted for these
22 community meetings; and

23 WHEREAS, These residents do not have the opportunity to
24 participate in the community planning process; now, therefore, be it

1 RESOLVED, That the Board of Supervisors of the City and County
2 of San Francisco urges the Planning Department to establish
3 procedures for cell site community meeting notification in
4 appropriate languages; and, be it

5 FURTHER RESOLVED, That the Board of Supervisors requests that
6 the Planning Department report back to the Board of Supervisors in
7 three months.


