3 **Resolution enacting and rescinding traffic regulations on various streets.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the movement of
7 vehicles are hereby enacted or rescinded as designated below:

8 **ONE-WAY STREET (WESTBOUND) - ESTABLISH**

9 Cleveland Street, between Sherman and 7th Streets

10 **NO LEFT TURN OR NO U-TURNS - ESTABLISH**

11 Cesar Chavez Street, westbound traffic at South Van Ness Avenue


12 **ONE-WAY STREET (NORTHBOUND) - ESTABLISH**

13 Ellsworth Street, from Crescent Avenue to a point approximately 890 feet southerly
14 (extends the existing one-way regulation by 160 feet southerly)

15 **STREET CLOSURE EXCEPT DURING SCHOOL SUMMER RECESS - ESTABLISH**

16 Sherman Street, from Cleveland Street to 100 feet north of Harrison Street (250 feet).

18 Categorically exempt from Environmental
19 Review Class 1(c)(9) changes in the traffic and
20 parking regulations where such changes do not
21 establish a higher speed limit or result in more
22 than a negligible increase in the use of the
23 street.

Sherman Street, from Cleveland Street to 100 feet north of Harrison Street (250 feet).




