3 **Resolution retroactively authorizing the Department of Public Health to accept and**
4 **expend a grant in the amount of \$750,000 from the California Department of Health**
5 **Care Service through Heluna Health for participation in a program, entitled “San**
6 **Francisco Department of Public Health (SFDPH) Behavioral Health Service (BHS)**
7 **Children, Youth and Families (CYF) Proposed Approach for implementing Modular**
8 **Approach to Therapy for Children with Anxiety, Depression, Trauma, or Conduct**
9 **Problems (MATCH),” for the period of October 4, 2024, through June 30, 2025.**

11 WHEREAS, The California Department of Health Care Service (DHCS) through Heluna
12 Health (HH), has agreed to fund the Department of Public Health (DPH) in the amount of
13 \$750,000 for participation in a program, entitled “San Francisco Department of Public Health
14 (SFDPH) Behavioral Health Service (BHS) Children, Youth and Families (CYF) Proposed
15 Approach for implementing Modular Approach to Therapy for Children with Anxiety,
16 Depression, Trauma, or Conduct Problems (MATCH),” for the period of October 4, 2024,
17 through June 30, 2025; and

18 WHEREAS, The Department of Health Care Services (DHCS) Child and Youth
19 Behavioral Health Initiative (CYBHI) Evidence Based and Community Defined Evidence
20 practices Round 2 funds trauma informed program and practices to increase access to
21 services that address Behavioral Health needs and the impact of Adverse Childhood
22 Experiences (ACEs); and

23 WHEREAS, Early interventions and increasing the availability of interventions that are
24 trauma informed can help reduce the negative effects of ACEs; and

1 WHEREAS, MATCH synthesizes decades of research into an expert-designed modular
2 system that tailors Cognitive Behavioral Therapy to the specific needs of youth ages 6-17
3 experiencing anxiety, depression, trauma, and/or conduct problems. MATCH will serve 384
4 youth over the grant; and

5 WHEREAS, An Annual Salary Ordinance Amendment is not required; and

6 WHEREAS, A request for retroactive approval is being sought because DPH received
7 the award letter on October 4, 2024, for a project start date of October 4, 2024; and

8 WHEREAS, The Department proposes to maximize use of available grant funds on
9 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

10 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
11 the grant budget; and, be it

12 FURTHER RESOLVED, That DPH is hereby authorized to accept and expend a grant
13 in the amount of \$750,000 from the DHCS through HH; and, be it

14 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
15 expend the grant funds pursuant to Administrative Code, Section 10.170-1.
