3 **Resolution declaring it a policy of the San Francisco Board of Supervisors to establish**
4 **a practice of dedicating a Day of Remembrance to any sworn public safety personnel**
5 **killed while in the line of duty.**

7 WHEREAS, The City and County of San Francisco has three City departments that
8 employ sworn public safety personnel that include: the San Francisco Police Department, Fire
9 Department, and Sheriff's Department; and

10 WHEREAS, The men and women in the Police, Fire, and Sheriff's Department put their
11 lives on the line each and every day that they put on their uniform and go to work on behalf of
12 the residents of San Francisco; and

13 WHEREAS, The men and women in the Police, Fire, and Sheriff's Department work
14 each and every day to engage with the community at large and strive to protect and enhance
15 public safety across San Francisco; and

16 WHEREAS, Tragically, members of the Police, Fire, and Sheriff's Department have
17 been killed while serving the public in the line of duty; now, therefore, be it

18 **RESOLVED**, That the San Francisco Board of Supervisors declares it a policy to
19 establish a practice of dedicating a Day of Remembrance to any City and County of San
20 Francisco sworn public safety personnel killed while in the line of duty.


