13 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
14 authorizes the City Attorney to settle the action entitled Jane Doe 1, et al. v. City and County  
15 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-592296, subject to  
16 the approval of the Probate Court, by the payment of \$2,223,500. The lawsuit involves  
17 allegations of abuse and privacy violations made by current and former residents of Laguna  
18 Honda Hospital and Rehabilitation Center.

19 Section 2. The above-named action was filed in San Francisco Superior Court on May  
20 28, 2021, and the following parties were named in the lawsuit: Plaintiffs Jane Doe 1, Jane


