1 [Clean and Safe Neighborhood Parks General Obligation Bond Sale - Not to Exceed  
2 \$76,000,000]

3  
4 **Resolution authorizing and directing the sale of not to exceed \$76,000,000 aggregate**  
5 **principal amount of City and County of San Francisco General Obligation Bonds (Clean**  
6 **and Safe Neighborhood Parks Bonds, 2008) Series 2012B; prescribing the form and**  
7 **terms of said bonds; authorizing the execution, authentication, and registration of said**  
8 **bonds; providing for the appointment of depositories and other agents for said bonds;**  
9 **providing for the establishment of accounts related thereto; providing for the manner**  
10 **of sale of said bonds by competitive sale; approving the forms of official notice of sale**  
11 **and notice of intention to sell bonds; directing the publication of the notice of intention**  
12 **to sell bonds; approving the form of the preliminary official statement and the form and**  
13 **execution of the official statement relating to the sale of said bonds; approving the**  
14 **form of the continuing disclosure certificate; approving modifications to documents;**  
15 **ratifying certain actions previously taken; declaring the City's intent to reimburse**  
16 **certain expenditures; waiving the deadline for submission of bond accountability**  
17 **reports; and granting general authority to City officials to take necessary actions in**  
18 **connection with the authorization, issuance, sale, and delivery of said bonds.**

19  
20 WHEREAS, By Resolution No. 343-08 (the "Authorizing Resolution"), adopted by the  
21 Board of Supervisors (the "Board") of the City and County of San Francisco (the "City") on  
22 July 29, 2008, and signed by the Mayor of the City (the "Mayor") on August 5, 2008, the City  
23 authorized the issuance of its General Obligation Bonds (Clean and Safe Neighborhood Parks  
24 Bonds, 2008) (the "Bonds"); and

1           WHEREAS, By Resolution No. 342-08, adopted by the Board on July 29, 2008, and  
2 signed by the Mayor on August 5, 2008, the City authorized the first series of Bonds not to  
3 exceed \$45,000,000 aggregate principal amount of said General Obligation Bonds (Clean and  
4 Safe Neighborhood Parks Bonds, 2008) Series 2008B; and

5           WHEREAS, By Resolution No. 45-10, adopted by the Board on February 9, 2010, and  
6 signed by the Mayor on February 18, 2010, the City authorized the second and third series of  
7 Bonds not to exceed \$65,000,000 aggregate principal amount of said General Obligation  
8 Bonds (Clean and Safe Neighborhood Parks Bonds, 2008) Series 2010B and General  
9 Obligation Bonds (Clean and Safe Neighborhood Parks Bonds, 2008) Series 2010D  
10 (Federally Taxable Build America Bonds); and

11           WHEREAS, The City has issued and sold, to date, a total of \$102,950,000 General  
12 Obligation Bonds (Clean and Safe Neighborhood Parks Bonds, 2008); and there remains  
13 \$82,050,000 of authorized and unissued General Obligation Bonds (Clean and Safe  
14 Neighborhood Parks Bonds, 2008); and

15           WHEREAS, It is necessary and desirable to issue an aggregate principal amount of not  
16 to exceed \$76,000,000 City and County of San Francisco General Obligation Bonds (Clean  
17 and Safe Neighborhood Parks Bonds, 2008) Series 2012B (the "Series 2012B Bonds"); and

18           WHEREAS, The Series 2012B Bonds are being issued pursuant to the Authorizing  
19 Resolution and Title 5, Division 2, Part 1, Chapter 3, Article 4.5 of the California Government  
20 Code, the Charter of the City (the "Charter"), and a duly held election called for by Ordinance  
21 No. 237-07 adopted by the Board on October 23, 2007, and signed by the Mayor on October  
22 24, 2007 (the "Bond Ordinance"); and

23           WHEREAS, The City has paid and expects to pay certain expenditures in connection  
24 with the projects to be financed by the Series 2012B Bonds prior to the issuance and sale of  
25

1 the Series 2012B Bonds, and the City intends to reimburse itself and to pay third parties for  
2 such prior expenditures from the proceeds of the Series 2012B Bonds; and

3 WHEREAS, Section 1.150-2 of the Treasury Regulations promulgated under the  
4 Internal Revenue Code of 1986 (the "Treasury Regulations") requires the City to declare its  
5 reasonable official intent to reimburse prior expenditures with the proceeds of a subsequent  
6 borrowing; and

7 WHEREAS, The Treasury Regulations require that any reimbursement allocation of  
8 proceeds of the Series 2012B Bonds to be made with respect to expenditures incurred prior to  
9 the issuance of the Series 2012B Bonds will occur not later than eighteen (18) months after  
10 the later of (i) the date on which the expenditure is paid or (ii) the date on which the facilities  
11 are placed in service, but in no event later than three (3) years after the expenditure is paid;  
12 and

13 WHEREAS, Section 2.71(b) of the City's Administrative Code provides that a Bond  
14 Accountability Report shall be submitted sixty (60) days prior to approval by the Board of the  
15 sale of any subsequent series of bonds for the same project; and

16 WHEREAS, the Recreation and Park Department will not meet the sixty (60) day  
17 deadline for submission of its Bond Accountability Report; and

18 WHEREAS, the Recreation and Park Department will submit its Bond Accountability  
19 Report prior to approval by the Board of the Series 2012 Bonds; and

20 WHEREAS, Section 2.71(e) of the City's Administrative Code provides the Board may  
21 waive the requirement for any accountability report by resolution; and

22 WHEREAS, the Recreation and Park Department desires that the Board waive the  
23 deadline for Bond Accountability Reports to be submitted with respect to the Series 2012  
24 Bonds; and

1           WHEREAS, The Citizens' General Obligation Bond Oversight Committee shall conduct  
2 an annual review of bond spending and shall provide an annual report on the management of  
3 the program to the Mayor, the Board, the Recreation and Park Commission, and the Port  
4 Commission, and, to the extent permitted by law, one-tenth of one percent (0.1%) of the gross  
5 proceeds of the Series 2012B Bonds shall be deposited in a fund established by the  
6 Controller's Office and appropriated by the Board at the direction of the Citizens' General  
7 Obligation Bond Oversight Committee to cover the costs of such Committee and its review  
8 process;

9           NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the City and  
10 County of San Francisco, as follows:

11           Section 1. Recitals. All of the recitals herein are true and correct.

12           Section 2. Conditions Precedent. All conditions, things and acts required by law to  
13 exist, to happen and to be performed precedent to the adoption of this Resolution exist, have  
14 happened and have been performed in due time, form and manner in accordance with  
15 applicable law, and the City is now authorized pursuant to the Charter and applicable law to  
16 incur indebtedness in the manner and form provided in this Resolution.

17           Section 3. Documents. The documents presented to the Board and on file with the  
18 Clerk of the Board of Supervisors or his or her designee (the "Clerk of the Board of  
19 Supervisors") are contained in File No. 111345.

20           Section 4. Issuance and Sale of Series 2012B Bonds. The Board hereby authorizes  
21 the issuance and sale of not to exceed \$76,000,000 in aggregate principal amount of the  
22 Bonds to be designated as "City and County of San Francisco General Obligation Bonds  
23 (Clean and Safe Neighborhood Parks Bonds, 2008) Series 2012B" for the purposes set forth  
24 in the Bond Ordinance and Proposition A approved by the voters on February 5, 2008. The  
25 Director of Public Finance of the City or his or her designee (the "Director of Public Finance")

1 is hereby authorized to determine the sale date, the interest rates, the definitive principal  
2 amount thereof, the maturity dates and the redemption dates, if any, and the terms of any  
3 optional or mandatory redemption thereof, subject to the other specific provisions of this  
4 Resolution, including the following terms and conditions: (i) the Series 2012B Bonds shall not  
5 have an interest rate in excess of 12% per year; and (ii) the Series 2012B Bonds shall not  
6 have a final maturity date after June 15, 2037. The Director of Public Finance is further  
7 authorized to give the Series 2012B Bonds such additional or other series designation, or to  
8 modify such series designation, as may be necessary or appropriate to distinguish such series  
9 from every other series of Bonds and from other bonds issued by the City.

10 Section 5. Execution, Authentication and Registration of the Series 2012B Bonds. The  
11 Series 2012B Bonds shall be in fully registered form without coupons in denominations of  
12 \$5,000 or any integral multiple thereof. The Controller of the City or his or her designee (the  
13 "Controller") is hereby directed to cause the Series 2012B Bonds to be prepared in sufficient  
14 quantity for delivery to or for the account of the purchaser thereof and the Controller is hereby  
15 directed to cause the blanks therein to be completed in accordance with the Authorizing  
16 Resolution, to procure their execution by the proper officers of the City (including by facsimile  
17 signature if necessary or convenient), and to deliver the Series 2012B Bonds when so  
18 executed to said purchaser in exchange for the purchase price thereof, all in accordance with  
19 the Authorizing Resolution.

20 The Series 2012B Bonds and the certificate of authentication and registration, manually  
21 executed by the Treasurer of the City or his or her designee (the "City Treasurer") and the  
22 form of assignment to appear thereon shall be substantially in the form attached hereto as  
23 Exhibit A (a copy of which is on file with the Clerk of the Board of Supervisors and which is  
24 hereby declared to be a part of this Resolution as if fully set forth herein), with such necessary  
25

1 or appropriate variations, omissions and insertions as permitted or required by this Resolution  
2 and made in accordance with Section 19 hereof.

3 Only such of the Series 2012B Bonds as shall bear thereon a certificate of  
4 authentication and registration in the form herein recited, executed by the City Treasurer, shall  
5 be valid or obligatory for any purpose or entitled to the benefits of this Resolution, and such  
6 certificate of the City Treasurer, executed as herein provided, shall be conclusive evidence  
7 that the Series 2012B Bonds so authenticated have been duly authenticated and delivered  
8 hereunder and are entitled to the benefits of this Resolution.

9 The Controller shall assign a distinctive letter, or number, or letter and number to each  
10 Series 2012B Bond authenticated and registered by the City Treasurer and shall maintain a  
11 record thereof which shall be available for inspection.

12 Section 6. Registration Books. The City Treasurer shall keep or cause to be kept, at  
13 the office of the City Treasurer, or at the designated office of any registrar appointed by the  
14 City Treasurer, separate and sufficient books for the registration and transfer of the Series  
15 2012B Bonds, which bond registration books shall at all times be open to inspection, and  
16 upon presentation for such purpose, the City Treasurer shall, under such reasonable  
17 regulations as he or she may prescribe, register or transfer or cause to be registered or  
18 transferred, on said books, Series 2012B Bonds as herein provided. The City and the City  
19 Treasurer may treat the registered owners of the Series 2012B Bonds (each, a "Registered  
20 Owner") as the absolute owners thereof for all purposes, and the City and the City Treasurer  
21 shall not be affected by any notice to the contrary.

22 Section 7. Transfer or Exchange of Series 2012B Bonds. Any Series 2012B Bond  
23 may, in accordance with its terms, be transferred upon the bond registration books required to  
24 be kept pursuant to the provisions of Section 6 hereof, by the person in whose name it is  
25 registered, in person or by the duly authorized attorney of such person in writing, upon

1 surrender of such Series 2012B Bond for cancellation, accompanied by delivery of a duly  
2 executed written instrument of transfer in a form approved by the City Treasurer.

3 Any Series 2012B Bonds may be exchanged at the office of the City Treasurer for a  
4 like aggregate principal amount of other authorized denominations of the same series, interest  
5 rate, and maturity.

6 Whenever any Series 2012B Bond shall be surrendered for transfer or exchange, the  
7 designated City officials shall execute (as provided in Section 5 hereof) and the City Treasurer  
8 shall authenticate and deliver a new Series 2012B Bond of the same series, interest rate and  
9 maturity in a like aggregate principal amount. The City Treasurer shall require the payment by  
10 any Registered Owner requesting any such transfer of any tax or other governmental charge  
11 required to be paid with respect to such transfer or exchange.

12 No transfer or exchange of Series 2012B Bonds shall be required to be made by the  
13 City Treasurer during the period from the Record Date (as defined in Section 8 hereof) next  
14 preceding each interest payment date to such interest payment date or after a notice of  
15 redemption shall have been mailed with respect to such Series 2012B Bond.

16 Section 8. General Terms of the Series 2012B Bonds; Redemption Provisions.

17 (a) General Terms. The Series 2012B Bonds shall be dated the date of their  
18 delivery or such other date (the "Dated Date"), as specified in the Bond Award (as defined in  
19 Section 13 hereof). The Series 2012B Bonds shall bear interest at rates to be determined  
20 upon the sale of the Series 2012B Bonds, calculated on the basis of a 360-day year  
21 comprised of twelve 30-day months, payable on June 15, 2012 (or such other date as may be  
22 designated in the Bond Award), and semiannually thereafter on June 15 and December 15 of  
23 each year.

24 The principal of the Series 2012B Bonds shall be payable in lawful money of the United  
25 States of America to the Registered Owner thereof, upon the surrender thereof at maturity or



1 earlier redemption at the office of the City Treasurer. The interest on the Series 2012B Bonds  
2 shall be payable in like lawful money to the Registered Owner whose name appears on the  
3 bond registration books of the City Treasurer as the Registered Owner thereof as of the close  
4 of business on the last day of the month immediately preceding an interest payment date (the  
5 "Record Date"), whether or not such day is a Business Day (as defined below).

6 Each Series 2012B Bond shall bear interest from the interest payment date next  
7 preceding the date of authentication thereof unless it is authenticated as of a day during the  
8 period from the Record Date next preceding any interest payment date to the interest  
9 payment date, inclusive, in which event it shall bear interest from such interest payment date,  
10 or unless it is authenticated on or before the first Record Date, in which event it shall bear  
11 interest from the Dated Date; provided, however, that if, at the time of authentication of any  
12 Series 2012B Bond, interest is in default on the Series 2012B Bonds, such Series 2012B  
13 Bond shall bear interest from the interest payment date to which interest has previously been  
14 paid or made available for payment on the Series 2012B Bonds or from the Dated Date if the  
15 first interest payment is not made. Except as may be otherwise provided in connection with  
16 any book-entry only system applicable to the Series 2012B Bonds, payment of the interest on  
17 any Series 2012B Bond shall be made by check mailed on the interest payment date to its  
18 Registered Owner at such Registered Owner's address as it appears on the registration  
19 books as of the Record Date; provided, however, if any interest payment date occurs on a day  
20 that banks in California or New York are closed for business or the New York Stock Exchange  
21 is closed for business, then such payment shall be made on the next succeeding day that  
22 banks in both California and New York are open for business and the New York Stock  
23 Exchange is open for business (each, a "Business Day"); and provided, further, that the  
24 Registered Owner of an aggregate principal amount of at least \$1,000,000 of the Series  
25 2012B Bonds may submit a written request to the City Treasurer on or before a Record Date

1 preceding an interest payment date for payment of interest by wire transfer to a commercial  
2 bank located within the United States of America. For so long as the Series 2012B Bonds are  
3 held in book-entry form by a securities depository selected by the City pursuant to Section 11  
4 hereof, payment shall be made to the Registered Owner of the Series 2012B Bonds  
5 designated by such securities depository by wire transfer of immediately available funds.

6 (b) Optional Redemption. The Series 2012B Bonds shall be subject to optional  
7 redemption prior to maturity as provided in the Official Notice of Sale or the Bond Award.

8 (c) Sinking Fund Redemption. The Series 2012B Bonds shall be subject to  
9 mandatory redemption at par, by lot, in any year for which the purchaser thereof has  
10 designated that the principal amount payable with respect to that year shall constitute a  
11 mandatory sinking fund payment, as and to the extent permitted by the Official Notice of Sale.  
12 Any Series 2012B Bonds subject to mandatory redemption shall be designated as such in the  
13 Official Notice of Sale or the Bond Award. The principal of and interest on the Series 2012B  
14 Bonds subject to mandatory redemption shall be paid from the Series 2012B Bond Account  
15 (as defined in Section 9 hereof), pursuant to Section 9 hereof. In lieu of any such mandatory  
16 redemption for the Series 2012B Bonds, at any time prior to the selection of the Series 2012B  
17 Bonds for mandatory redemption, the City may apply such amounts on deposit in the Series  
18 2012B Bond Account to purchase Series 2012B Bonds subject to such redemption at public  
19 or private sale, as and when and at such prices not in excess of the principal amount thereof  
20 (including sales commission and other charges but excluding accrued interest), as the City  
21 may determine.

22 (d) Redemption – Selection. Whenever less than all of the outstanding Series  
23 2012B Bonds maturing on any one date are called for redemption on any one date, the City  
24 Treasurer will select the Series 2012B Bonds or portions thereof, in denominations of \$5,000  
25 or any integral multiple thereof, to be redeemed from the outstanding Series 2012B Bonds

1 maturing on such date not previously selected for redemption, by lot, in any manner which the  
2 City Treasurer deems fair.

3 The date on which the Series 2012B Bonds that are called for redemption are to be  
4 presented for redemption is herein called the "Redemption Date."

5 (e) Redemption – Notice. The City Treasurer shall mail, or cause to be mailed,  
6 notice of any redemption of the Series 2012B Bonds, postage prepaid, to the respective  
7 Registered Owners thereof at the addresses appearing on the bond registration books not  
8 less than twenty (20) days prior to the Redemption Date. The notice of redemption shall (1)  
9 state the Redemption Date; (2) state the redemption price; (3) state the maturity dates of the  
10 Series 2012B Bonds and, if less than all of any such maturity is called for redemption, the  
11 distinctive numbers of the Series 2012B Bonds of such maturity to be redeemed, and in the  
12 case of any Series 2012B Bonds redeemed in part only, the respective portions of the  
13 principal amount thereof to be redeemed; (4) state the CUSIP number, if any, of each Series  
14 2012B Bond to be redeemed; (5) require that such Series 2012B Bonds be surrendered by  
15 the Registered Owners at the office of the City Treasurer or his or her agent; and (6) give  
16 notice that interest on such Series 2012B Bonds will cease to accrue after the designated  
17 Redemption Date. Such notice of redemption may be conditional as provided in Section 8(g)  
18 hereof.

19 The actual receipt by the Registered Owner of any Series 2012B Bond of notice of  
20 such redemption shall not be a condition precedent to redemption, and failure to receive such  
21 notice, or any defect in such notice so mailed, shall not affect the validity of the proceedings  
22 for the redemption of such Series 2012B Bonds or the cessation of accrual of interest on such  
23 Series 2012B Bonds on the Redemption Date.

24 Notice of such redemption also shall be given, or caused to be given, by the City  
25 Treasurer, by (i) registered or certified mail, postage prepaid, (ii) confirmed facsimile

1 transmission or (iii) overnight delivery service, to (A) all organizations registered with the  
2 Securities and Exchange Commission as securities depositories and (B) such other services  
3 or organizations as may be required in accordance with the Continuing Disclosure Certificate  
4 described in Section 18 hereof.

5 The notice or notices required for redemption shall be given by the City Treasurer, or  
6 any agent appointed by the City. A certificate of the City Treasurer or such other appointed  
7 agent of the City that notice of redemption has been given to the Registered Owner of any  
8 Series 2012B Bond in accordance with this Resolution shall be conclusive against all parties.

9 (f) Payment for Optional Redemption. At the time the City Treasurer or the  
10 Controller determines to optionally call and redeem any of the Series 2012B Bonds, the City  
11 Treasurer or his or her agent shall establish a redemption account to be described or known  
12 as the "General Obligation Bonds (Clean and Safe Neighborhood Parks Bonds, 2008) Series  
13 2012B Redemption Account" (the "Series 2012B Redemption Account"), and prior to or on the  
14 Redemption Date there must be set aside in the Series 2012B Redemption Account moneys  
15 available for the purpose and sufficient to redeem, as provided in this Resolution, the Series  
16 2012B Bonds designated in said notice of redemption, subject to rescission as hereinafter  
17 provided. Said moneys must be set aside in the Series 2012B Redemption Account solely for  
18 the purpose of, and shall be applied on or after the Redemption Date to, payment of the  
19 redemption price of the Series 2012B Bonds to be redeemed upon presentation and  
20 surrender of such Series 2012B Bonds. Any interest due on or prior to the Redemption Date  
21 may be paid from the Series 2012B Bond Account as provided in Section 9 hereof or from the  
22 Series 2012B Redemption Account. Moneys held from time to time in the Series 2012B  
23 Redemption Account shall be invested by the City Treasurer pursuant to the City's policies  
24 and guidelines for investment of moneys in the General Fund of the City. If, after all of the  
25 Series 2012B Bonds have been redeemed and canceled or paid and canceled, there are

1 moneys remaining in said Series 2012B Redemption Account, said moneys shall be  
2 transferred to the General Fund of the City or to such other fund or account as required by  
3 applicable law; provided, however, that if said moneys are part of the proceeds of refunding  
4 bonds, said moneys shall be transferred pursuant to the resolution authorizing such refunding  
5 bonds.

6 When notice of optional redemption has been given, substantially as provided herein,  
7 and when the amount necessary for the redemption of the Series 2012B Bonds called for  
8 redemption (principal, premium, if any, and accrued interest to such Redemption Date) is set  
9 aside for that purpose in said Series 2012B Redemption Account, as provided herein, the  
10 Series 2012B Bonds designated for redemption shall become due and payable on the  
11 Redemption Date therefor, and upon presentation and surrender of said Series 2012B Bonds  
12 at the place specified in the notice of redemption, such Series 2012B Bonds shall be  
13 redeemed and paid at said redemption price out of said Series 2012B Redemption Account.  
14 No interest will accrue on such Series 2012B Bonds called for redemption after the  
15 Redemption Date and the Registered Owners of such Series 2012B Bonds shall look for  
16 payment of such Series 2012B Bonds only to said Series 2012B Redemption Account. All  
17 Series 2012B Bonds redeemed shall be canceled forthwith by the City Treasurer and shall not  
18 be reissued.

19 (g) Conditional Notice of Optional Redemption. Any notice of optional redemption  
20 given as provided in Section 8(e) may provide that such redemption is conditioned upon: (i)  
21 deposit in the Series 2012B Redemption Account of sufficient moneys to redeem the Series  
22 2012B Bonds called for redemption on the anticipated Redemption Date, or (ii) any other  
23 event specified in the notice of redemption. In the event that such conditional notice of  
24 optional redemption has been given, substantially as provided herein, and on the scheduled  
25 Redemption Date (i) sufficient moneys to redeem the Series 2012B Bonds have not been

1 deposited in the Series 2012B Redemption Account or (ii) any other event specified in the  
2 notice of redemption did not occur, such Series 2012B Bonds for which notice of conditional  
3 optional redemption was given shall not be redeemed and shall remain Outstanding for all  
4 purposes of this Resolution and the redemption not occurring shall not constitute an event of  
5 default under this Resolution or the Authorizing Resolution.

6 (h) Rescission of Optional Redemption. The City may rescind any optional  
7 redemption and notice thereof for any reason on any date prior to the Redemption Date by  
8 causing written notice of the rescission to be given to the Registered Owners of all Series  
9 2012B Bonds so called for redemption. Notice of such rescission of redemption shall be given  
10 in the same manner notice of redemption was originally given. The actual receipt by the  
11 Registered Owner of any Series 2012B Bond of notice of such rescission shall not be a  
12 condition precedent to rescission, and failure to receive such notice or any defect in such  
13 notice so mailed shall not affect the validity of the rescission.

14 Section 9. Series 2012B Bond Account. There is hereby established with the City  
15 Treasurer a special subaccount in the General Obligation Bonds (Clean and Safe  
16 Neighborhood Parks Bonds, 2008) Bond Account (the "Bond Account") created pursuant to  
17 the Authorizing Resolution, to be designated the "General Obligation Bonds (Clean and Safe  
18 Neighborhood Parks Bonds, 2008) Series 2012B Bond Account" (the "Series 2012B Bond  
19 Account"), to be held separate and apart from all other accounts of the City. Any bid premium  
20 or accrued interest received upon the delivery of the Series 2012B Bonds shall be deposited  
21 into the Series 2012B Bond Account. All interest earned on amounts on deposit in the Series  
22 2012B Bond Account shall be retained in the Series 2012B Bond Account.

23 On or prior to the date on which any payment of principal of or interest on the Series  
24 2012B Bonds is due, including any Series 2012B Bonds subject to mandatory redemption on  
25 said date, the City Treasurer shall allocate to and deposit in the Series 2012B Bond Account,

1 from amounts held in the Bond Account, an amount which, when added to any available  
2 moneys contained in the Series 2012B Bond Account, is sufficient to pay principal of and  
3 interest on the Series 2012B Bonds on such date.

4 On or prior to the date on which any Series 2012B Bonds are to be redeemed at the  
5 option of the City pursuant to this Resolution, the City Treasurer may allocate to and deposit  
6 in the Series 2012B Redemption Account, from amounts held in the Bond Account pursuant to  
7 Section 8 of the Authorizing Resolution, an amount which, when added to any available  
8 moneys contained in the Series 2012B Redemption Account, is sufficient to pay principal,  
9 interest and premium, if any, with respect to such Series 2012B Bonds on such date. The  
10 City Treasurer may make such other provision for the payment of principal of and interest and  
11 any redemption premium on the Series 2012B Bonds as is necessary or convenient to permit  
12 the optional redemption of the Series 2012B Bonds.

13 Amounts in the Series 2012B Bond Account may be invested in any investment of the  
14 City in which moneys in the General Fund of the City are invested. The City Treasurer may  
15 commingle any of the moneys held in the Series 2012B Bond Account with other City moneys  
16 or deposit amounts credited to the Series 2012B Bond Account into a separate fund or funds  
17 for investment purposes only; provided, however, that all of the moneys held in the Series  
18 2012B Bond Account hereunder shall be accounted for separately notwithstanding any such  
19 commingling or separate deposit by the City Treasurer.

20 Section 10. Series 2012B Project Account. There is hereby established with the City  
21 Treasurer a special subaccount in the General Obligation Bonds (Clean and Safe  
22 Neighborhood Parks Bonds, 2008) Project Account (the "Project Account") created pursuant  
23 to the Authorizing Resolution to be designated the "General Obligation Bonds (Clean and  
24 Safe Neighborhood Parks Bonds, 2008) Series 2012B Project Account" (the "Series 2012B  
25 Project Account"), to be held separate and apart from all other accounts of the City. All

1 interest earned on amounts on deposit in the Series 2012B Project Account shall be retained  
2 in the Series 2012B Project Account. Amounts in the Series 2012B Project Account shall be  
3 expended in accordance with the provisions of the Authorizing Resolution for the acquisition,  
4 renovation and construction of the Project (as defined in the Authorizing Resolution) or  
5 portions thereof.

6 Amounts in the Series 2012B Project Account may be invested in any investment of the  
7 City in which moneys in the General Fund of the City are invested. The City Treasurer may  
8 commingle any of the moneys held in the Series 2012B Project Account with other City  
9 moneys or deposit amounts credited to the Series 2012B Project Account into a separate fund  
10 or funds for investment purposes only; provided, however, that all of the moneys held in the  
11 Series 2012B Project Account (including interest earnings) hereunder shall be accounted for  
12 separately notwithstanding any such commingling or separate deposit by the City Treasurer.

13 The City Treasurer is hereby authorized to pay or cause to be paid from the proceeds  
14 of the Series 2012B Bonds in the Series 2012B Project Account, on behalf of the City, the  
15 costs of issuance associated with the Series 2012B Bonds. Costs of issuance of the Series  
16 2012B Bonds shall include, without limitation, bond and financial printing expenses, mailing  
17 and publication expenses, rating agency fees, the fees and expenses of paying agents,  
18 registrars, financial consultants, disclosure counsel and co-bond counsel and the  
19 reimbursement of departmental expenses in connection with the issuance of the Series 2012B  
20 Bonds.

21 Section 11. Appointment of Securities Depositories and Other Agents. The  
22 Depository Trust Company ("DTC") is hereby appointed as securities depository for the Series  
23 2012B Bonds. The Series 2012B Bonds shall be initially issued only in book-entry form.  
24 Upon initial issuance, the ownership of each Series 2012B Bond shall be registered in the  
25 bond registration books in the name of Cede & Co., as nominee of DTC. So long as the



1 Series 2012B Bonds are registered in book-entry form, the 2011A Bonds shall be registered in  
2 the name of Cede & Co. The City will not have any responsibility or obligation to any  
3 purchaser of a beneficial ownership interest in any Series 2012B Bonds or to any participants  
4 in DTC or any successor securities depository with respect to (i) the accuracy of any records  
5 maintained by such securities depository or any participant therein; (ii) any notice that is  
6 permitted or required to be given to the Registered Owners of the Series 2012B Bonds under  
7 this Resolution; (iii) the selection by such securities depository or any participant therein of  
8 any person to receive payment in the event of a partial redemption of the Series 2012B  
9 Bonds; (iv) the payment by such securities depository or any participant therein of any amount  
10 with respect to the principal or redemption premium, if any, or interest due with respect to the  
11 Series 2012B Bonds; (v) any consent given or other action taken by such securities  
12 depository as the Registered Owner of the Series 2012B Bonds; or (vi) any other matter.

13 The City Treasurer is hereby also authorized and directed to appoint one or more  
14 agents, as he or she may deem necessary or desirable. To the extent permitted by applicable  
15 law and under the supervision of the City Treasurer, such agents may serve as paying agent,  
16 fiscal agent, rebate calculation agent, escrow agent or registrar for the Series 2012B Bonds or  
17 may assist the City Treasurer in performing any or all of such functions and such other duties  
18 as the City Treasurer shall determine. If the City Treasurer appoints one or more paying  
19 agents, the procedures set forth in Section 8 hereof relating to registration of ownership of the  
20 Series 2012B Bonds and payments and redemption notices to Registered Owner of the  
21 Series 2012B Bonds may be modified to comply with the policies and procedures of such  
22 paying agent. Such agents shall serve under such terms and conditions as the City Treasurer  
23 shall determine. The City Treasurer may remove or replace agents appointed pursuant to this  
24 Section 11 at any time.

1           Section 12. Defeasance Provisions. Payment of all or any portion of the Series  
2 2012B Bonds may be provided for prior to such Series 2012B Bonds' respective stated  
3 maturities by irrevocably depositing with the City Treasurer (or any commercial bank or trust  
4 company designated by the City Treasurer to act as escrow agent with respect thereto):

5           (a)    An amount of cash equal to the principal amount of all of such Series 2012B  
6 Bonds or a portion thereof, and all unpaid interest thereon to maturity, except that in the case  
7 of the portion of a Series 2012B Bonds that are to be redeemed prior to such Series 2012B  
8 Bonds' respective stated maturities and in respect of which notice of such redemption shall  
9 have been given as provided in Section 8 hereof or an irrevocable election to give such notice  
10 shall have been made by the City, the amount to be deposited shall be the principal amount  
11 thereof, all unpaid interest thereon to the Redemption Date, and premium, if any, due on such  
12 Redemption Date; or

13           (b)    Defeasance Securities (as defined below) not subject to call, except as provided  
14 below in the definition thereof, maturing and paying interest at such times and in such  
15 amounts, together with interest earnings and cash, if required, as will, without reinvestment,  
16 as certified by an independent verification agent, be fully sufficient to pay the principal and all  
17 unpaid interest to maturity or to the Redemption Date, as the case may be, and premium, if  
18 any, due on the portion of the Series 2012B Bonds to be paid or redeemed, as such principal  
19 and interest come due; provided, that, in the case of such Series 2012B Bonds that are to be  
20 redeemed prior to maturity, notice of such redemption shall be given as provided in Section 8  
21 hereof or an irrevocable election to give such notice shall have been made by the City; then,  
22 all obligations of the City with respect to said outstanding Series 2012B Bonds shall cease  
23 and terminate, except only the obligation of the City to pay or cause to be paid from the funds  
24 deposited pursuant to paragraphs (a) or (b) of this Section 12, to the owners of such Series  
25 2012B Bonds all sums due with respect thereto and the obligations of the City pursuant to

1 Section 17 hereof; provided, that the City shall have received an opinion of nationally  
2 recognized bond counsel that provision for the payment of such Series 2012B Bonds has  
3 been made in accordance with this Section 12.

4 For purposes of this Section 12, "Defeasance Securities" shall mean any of the  
5 following that at the time are legal investments under the laws of the State of California for the  
6 moneys proposed to be invested therein:

- 7 (1) United States Obligations (as defined below); and  
8 (2) Pre-refunded fixed interest rate municipal obligations meeting the following  
9 conditions: (a) the municipal obligations are not subject to redemption prior to maturity, or the  
10 trustee has been given irrevocable instructions concerning their calling and redemption and  
11 the issuer has covenanted not to redeem such obligations other than as set forth in such  
12 instructions; (b) the municipal obligations are secured by cash or United States Obligations;  
13 (c) the principal of and interest on the United States Obligations (plus any cash in the escrow  
14 fund or the Series 2012B Redemption Account) are sufficient to meet the liabilities of the  
15 municipal obligations; (d) the United States Obligations serving as security for the municipal  
16 obligations are held by an escrow agent or trustee; (e) the United States Obligations are not  
17 available to satisfy any other claims, including those against the trustee or escrow agent; and  
18 (f) the municipal obligations are rated (without regard to any numerical modifier, plus or minus  
19 sign or other modifier), at the time of original deposit to the escrow fund, by any two Rating  
20 Agencies (as defined below) not lower than the rating then maintained by the respective  
21 Rating Agency on such United States Obligations.

22 For purposes of this Section 12, "United States Obligations" shall mean (i) direct and  
23 general obligations of the United States of America, or obligations that are unconditionally  
24 guaranteed as to principal and interest by the United States of America, including without  
25 limitation, the interest component of Resolution Funding Corporation (REFCORP) bonds that

1 have been stripped by request to the Federal Reserve Bank of New York in book-entry form  
2 or (ii) any security issued by an agency or instrumentality of the United States of America that  
3 is selected by the Director of Public Finance that results in the escrow fund being rated by any  
4 two Rating Agencies at the time of the initial deposit to the escrow fund and upon any  
5 substitution or subsequent deposit to the escrow fund no lower than the rating then  
6 maintained by the respective Rating Agency on United States Obligations described in clause  
7 (i) above.

8 For purposes of this Section 12, "Rating Agencies" shall mean Moody's Investors  
9 Service, Inc., Fitch Ratings, and Standard and Poor's Rating Services, a division of The  
10 McGraw-Hill Companies, Inc., or any other nationally-recognized bond rating agency that is  
11 the successor to any of the foregoing rating agencies or that is otherwise established after the  
12 date hereof.

13 Section 13. Official Notice of Sale. The form of proposed Official Notice of Sale  
14 inviting bids for the Series 2012B Bonds (the "Official Notice of Sale") submitted to the Board  
15 is hereby approved and adopted as the Official Notice of Sale inviting bids for the Series  
16 2012B Bonds, with such changes, additions and modifications as may be made in accordance  
17 with Section 19 hereof.

18 Bids shall be received on the date designated by the Director of Public Finance  
19 pursuant to the Official Notice of Sale. The Director of Public Finance is hereby authorized  
20 and directed to cause to be mailed or otherwise circulated to prospective bidders for the  
21 Series 2012B Bonds copies of the Official Notice of Sale, subject to such corrections,  
22 revisions or additions as may be acceptable to the Director of Public Finance.

23 The Controller is hereby authorized to award the Series 2012B Bonds to the bidder  
24 whose bid represents the lowest true interest cost to the City, all in accordance with the  
25 procedures described in the Official Notice of Sale, which award shall be set forth in a

1 certificate signed by the Controller setting forth the terms of the Series 2012B Bonds and the  
2 original purchaser thereof (the "Bond Award"). The Controller shall provide a copy of the  
3 Bond Award as soon as practicable to the Clerk of the Board of Supervisors and the Director  
4 of Public Finance; provided, however, that failure to provide such copies shall not affect the  
5 validity of the Bond Award.

6 Section 14. Publication of Notice of Intention to Sell Bonds. The form of proposed  
7 Notice of Intention to Sell the Series 2012B Bonds (the "Notice of Intention to Sell Bonds")  
8 submitted to the Board is hereby approved and adopted as the Notice of Intention to Sell  
9 Bonds for the Series 2012B Bonds, and the Director of Public Finance is hereby authorized  
10 and directed to cause the Notice of Intention to Sell Bonds, subject to such corrections,  
11 revisions or additions as may be made in accordance with Section 19 hereof, to be published  
12 once in The Bond Buyer or another financial publication generally circulated throughout the  
13 State of California.

14 Section 15. Sale of Series 2012B Bonds; Solicitation of Competitive Bids. The Board  
15 hereby authorizes the sale of the Series 2012B Bonds by solicitation of competitive bids for  
16 the purchase of the Series 2012B Bonds on the date and at the place determined in  
17 accordance with the Official Notice of Sale.

18 Section 16. Official Statement. The form of proposed Preliminary Official Statement  
19 describing the Series 2012B Bonds, including all appendices thereto (the "Preliminary Official  
20 Statement"), submitted to the Board is hereby approved and adopted as the Preliminary  
21 Official Statement describing the Series 2012B Bonds, with such additions, corrections and  
22 revisions as may be determined to be necessary or desirable and made in accordance with  
23 Section 19 hereof. The Controller or Director of Public Finance is each hereby authorized and  
24 directed to revise the Official Statement, as necessary, to conform it to the City's  
25 Comprehensive Annual Fiscal Report for the fiscal year ended June 30, 2011, subject to

1 review and approval by the City Attorney of the City (the "City Attorney"). The Controller is  
2 hereby authorized to cause the distribution of a Preliminary Official Statement deemed final  
3 for purposes of Securities and Exchange Commission Rule 15c2-12 promulgated under the  
4 Securities Exchange Act of 1934, as amended (the "Rule"), and to sign a certificate to that  
5 effect. The Director of Public Finance is hereby authorized and directed to cause to be  
6 printed and mailed or electronically distributed to prospective bidders for the Series 2012B  
7 Bonds copies of the Preliminary Official Statement in substantially the form of the Preliminary  
8 Official Statement approved and adopted hereby, as completed, supplemented, corrected or  
9 revised. The Controller is authorized and directed to approve, execute, and deliver the final  
10 Official Statement with respect to the Series 2012B Bonds, which final Official Statement shall  
11 be in the form of the Preliminary Official Statement, with such additions, corrections and  
12 revisions as may be determined to be necessary or desirable and made in accordance with  
13 Section 19 hereof and as are permitted under the Rule.

14 Section 17. Tax Covenants.

15 (a) General. The City hereby covenants with the owners and holders of the Series  
16 2012B Bonds that, notwithstanding any other provisions of this Resolution, it shall not take  
17 any action, or fail to take any action, if any such action or failure to take action would  
18 adversely affect the exclusion from gross income of interest on the Series 2012B Bonds under  
19 Section 103 of the Internal Revenue Code of 1986 (the "Code") and the regulations issued  
20 thereunder, as the same may be amended from time to time, and any successor provisions of  
21 law. Reference to a particular section of the Code shall be deemed to be a reference to any  
22 successor to any such section. The City shall not, directly or indirectly, use or permit the use  
23 of proceeds of the Series 2012B Bonds or any of the property financed or refinanced with  
24 proceeds of the Series 2012B Bonds, or any portion thereof, by any person other than a  
25 governmental unit (as such term is used in Section 141 of the Code), in such manner or to

1 such extent as would result in the loss of exclusion of interest on the Series 2012B Bonds  
2 from gross income for federal income tax purposes.

3 (b) Use of Proceeds. The City shall not take any action, or fail to take any  
4 action, if any such action or failure to take action would cause the Series 2012B Bonds to be  
5 "private activity bonds" within the meaning of Section 141 of the Code, and in furtherance  
6 thereof, shall not make any use of the proceeds of the Series 2012B Bonds or any of the  
7 property financed or refinanced with proceeds of the Series 2012B Bonds, or any portion  
8 thereof, or any other funds of the City, that would cause the Series 2012B Bonds to be  
9 "private activity bonds" within the meaning of Section 141 of the Code. To that end, so long  
10 as any Series 2012B Bonds are outstanding, the City, with respect to such proceeds and  
11 property and such other funds, will comply with applicable requirements of the Code and all  
12 regulations of the United States Department of the Treasury issued thereunder and under  
13 Section 103 of the Internal Revenue Code of 1954, as amended (the "1954 Code"), to the  
14 extent such requirements are, at the time, applicable and in effect. The City has established  
15 reasonable procedures necessary to ensure continued compliance with Section 141 of the  
16 Code (or, if applicable, the 1954 Code) and the continued qualification of the Series 2012B  
17 Bonds as "governmental bonds."

18 (c) Arbitrage. The City shall not, directly or indirectly, use or permit the use of any  
19 proceeds of any Series 2012B Bonds, or of any property financed or refinanced thereby, or  
20 other funds of the City, or take or omit to take any action, that would cause the Series 2012B  
21 Bonds to be "arbitrage bonds" within the meaning of Section 148 of the Code. To that end,  
22 the City shall comply with all requirements of Section 148 of the Code and all regulations of  
23 the United States Department of the Treasury issued thereunder to the extent such  
24 requirements are, at the time, in effect and applicable to the Series 2012B Bonds.

1 (d) Federal Guarantee. The City shall not make any use of the proceeds of the  
2 Series 2012B Bonds or any other funds of the City, or take or omit to take any other action,  
3 that would cause the Series 2012B Bonds to be "federally guaranteed" within the meaning of  
4 Section 149(b) of the Code.

5 (e) Information Reporting. The City shall take or cause to be taken all necessary  
6 action to comply with the informational reporting requirement of Section 149(e) of the Code  
7 with respect to the Series 2012B Bonds.

8 (f) Hedge Bonds. The City shall not make any use of the proceeds of the Series  
9 2012B Bonds or any other amounts or property, regardless of the source, or take any action  
10 or refrain from taking any action that would cause the Series 2012B Bonds to be considered  
11 "hedge bonds" within the meaning of Section 149(g) of the Code unless the City takes all  
12 necessary action to assure compliance with the requirements of Section 149(g) of the Code.

13 (g) Compliance with Tax Certificate. In furtherance of the foregoing tax covenants  
14 of this Section 17, the City covenants that it will comply with the provisions of the Tax  
15 Certificate to be executed by the City with respect to the Series 2012B Bonds, dated the date  
16 of issuance of the Series 2012B Bonds, as such Tax Certificate may be amended from time to  
17 time. This covenant shall survive payment in full or defeasance of the Series 2012B Bonds.

18 Section 18. Continuing Disclosure Certificate. The form of Continuing Disclosure  
19 Certificate (the "Continuing Disclosure Certificate") to be signed by the City to permit the  
20 original purchaser of the Series 2012B Bonds to comply with the Rule, submitted to the Board  
21 is hereby approved and adopted as the Continuing Disclosure Certificate, with such additions,  
22 corrections and revisions as may be determined to be necessary or desirable and made in  
23 accordance with Section 19 hereof. The Controller is hereby authorized and directed to  
24 execute the Continuing Disclosure Certificate on behalf of the City and deliver the Continuing  
25 Disclosure Certificate to the original purchaser of the Series 2012B Bonds.



1           Section 19. Modification to Documents. Any City official authorized by this Resolution  
2 to execute any document is hereby further authorized, in consultation with the City Attorney  
3 and co-bond counsel, to approve and make such changes, additions, amendments or  
4 modifications to the document or documents such official is authorized to execute as may be  
5 necessary or advisable (provided that such changes, additions, amendments or modifications  
6 shall not authorize an aggregate principal amount of Series 2012B Bonds in excess of  
7 \$76,000,000 or conflict with the provisions of Section 4 hereof). The approval of any change,  
8 addition, amendment or modification to any of the aforementioned documents shall be  
9 evidenced conclusively by the execution and delivery of the document in question.

10           Section 20. Ratification. All actions heretofore taken by officials, employees and  
11 agents of the City with respect to the sale and issuance of the Series 2012B Bonds are  
12 hereby approved, confirmed and ratified.

13           Section 21. Relationship to Authorizing Resolution. In the event of any conflict  
14 between this Resolution and the Authorizing Resolution, the terms of this Resolution shall  
15 control. Without limiting the foregoing and notwithstanding the provisions of the Authorizing  
16 Resolution, the City is not obligated to transfer money from the General Fund of the City to the  
17 Bond Account to pay the principal of or interest on the Series 2012B Bonds.

18           Section 22. Reimbursement. The City hereby declares its official intent to reimburse  
19 prior expenditures of the City incurred prior to the issuance and sale of the Series 2012B  
20 Bonds in connection with the Project or portions thereof to be financed by the Series 2012B  
21 Bonds. The Board hereby declares the City's intent to reimburse the City with the proceeds of  
22 the Series 2012B Bonds for the expenditures with respect to the Project (the "Expenditures"  
23 and each, an "Expenditure") made on and after that date that is no more than 60 days prior to  
24 adoption of this Resolution. The City reasonably expects on the date hereof that it will  
25 reimburse the Expenditures with the proceeds of the Series 2012B Bonds. Each Expenditure

1 was and will be either (a) of a type properly chargeable to a capital account under general  
2 federal income tax principles (determined in each case as of the date of the Expenditure), (b)  
3 a cost of issuance with respect to the Series 2012B Bonds, (c) a nonrecurring item that is not  
4 customarily payable from current revenues, or (d) a grant to a party that is not related to or an  
5 agent of the City so long as such grant does not impose any obligation or condition (directly or  
6 indirectly) to repay any amount to or for the benefit of the City. The City shall make a  
7 reimbursement allocation, which is a written allocation by the City that evidences the City's  
8 use of proceeds of the Series 2012B Bonds to reimburse an Expenditure, no later than 18  
9 months after the later of the date on which the Expenditure is paid or the Project is placed in  
10 service or abandoned, but in no event more than three years after the date on which the  
11 Expenditure is paid. The City recognizes that exceptions are available for certain "preliminary  
12 expenditures," costs of issuance, certain de minimis amounts, expenditures by "small issuers"  
13 (based on the year of issuance and not the year of expenditure) and expenditures for  
14 construction projects of at least 5 years.

15 Section 23. Accountability Reports. The Series 2012B Bonds are subject to  
16 accountability requirements under the City's Administrative Code and the Bond Ordinance.  
17 The deadline for submission of the Recreation and Park Department's Accountability Report  
18 under Administrative Code section 2.71(b) is hereby waived with respect to the Series 2012 B  
19 Bonds. Accountability report(s) with respect to the Series 2012B Bonds shall be submitted in  
20 all other respects in the manner required by the Administrative Code and the Bond Ordinance.

21 Section 24. Citizens' Oversight Committee. The Series 2012B Bonds are subject to,  
22 and incorporate by reference, the applicable provisions of San Francisco Administrative Code  
23 Sections 5.30 - 5.36 (the "Citizens' General Obligation Bond Oversight Committee"), and, to  
24 the extent permitted by law, one-tenth of one percent (0.1%) of the gross proceeds of the  
25 Series 2012B Bonds shall be deposited in a fund established by the Controller's Office and



## EXECUTIVE SUMMARY

### Legislative Objectives

- File 11-1345: Resolution authorizing and directing the sale of not-to-exceed \$76,000,000 aggregate principal amount of Clean and Safe Neighborhood Parks General Obligation Bonds, Series 2012B.
- File 11-1334: Ordinance appropriating \$76,000,000 of Clean and Safe Neighborhood Parks Bond sale proceeds to fund improvement and construction of recreation and park facilities, including \$62,176,132 in the Recreation and Park Department and \$10,394,975 in the Port Commission.
- File 11-1364: Hearing to consider the release of reserved funds in the amount of \$130,463 to fund the Port's Pier 43 Bay Trail Link Waterfront Park Project.

### Key Points

- San Francisco voters approved the \$185 million Clean and Safe Neighborhood Parks Bonds in February 2008 to pay for capital improvements to Recreation and Park Department parks, recreation facilities, playgrounds, and restrooms, and Port parks. The City has previously sold \$102,950,000 in two prior bond sales. The proposed resolution (File 11-1345) would authorize the third sale of not-to-exceed \$76,000,000, resulting in total sale of Clean and Safe Neighborhood Parks Bonds of \$178,950,000, and an unsold balance of \$6,050,000.
- Recreation and Park Department programs and Port programs funded by the 2008 Clean and Safe Neighborhood Park Bonds will be fully funded if the Board of Supervisors approves the proposed appropriation ordinance (File 11-1334), with the exception of the Port's Crane Cove project. According to the November 28, 2011 Bond Accountability Report, submitted by the Port to the Board of Supervisors, the Crane Cove Park project has not yet received environmental clearance consistent with the California Environmental Quality Act (CEQA), which is estimated to be completed in 2013.
- The requested release of reserves of \$130,463 (File 11-1364) and the proposed supplemental appropriation of \$27,800 (File 11-1334) would fully fund the Port's Pier 43 Bay Trail Link project to provide open space and a public promenade in the Fisherman's Wharf area.

### Fiscal Impact

- The proposed resolution authorizing the sale of up to \$76,000,000 in Clean and Safe Neighborhood Park Bonds and will have a projected annual interest rate of 6.0 percent over approximately 20 years, with estimated total debt service payments of \$125,750,823, including \$52,480,823 in interest and \$73,270,000 in principal, with estimated average annual debt service payments of \$6,287,541. Debt service would be paid from increased Property Taxes, such that an owner of a single family residence with an assessed value of \$500,000 would pay additional Property Taxes of approximately \$14.30 per year

### Policy Issues

- The proposed resolution authorizing the sale of the Series 2012B Bonds would allow the Recreation and Park Department to waive the deadline for submitting the Bond Accountability Report. According to Ms. Taylor Emerson, Recreation and Park Department Capital and Planning Division Analyst, the Bond Accountability Report will be submitted to the Clerk of the Board of Supervisors on or before January 10, 2012.
- The Recreation and Park Department's total prior and requested Clean and Safe Neighborhood Parks Bond authorization of \$150,005,861 is \$990,861 more than the budget of \$149,015. This increase of \$990,861 results from an increase in the Recreation and Park Department's Neighborhood Park Contingency Fund, offset by decreases in other Neighborhood Parks projects. The Budget and Legislative Analyst recommends reducing the requested appropriation for the Neighborhood Parks Contingency Fund by \$990,861 to conform to the Clean and Safe Neighborhood Parks budget.
- The proposed appropriation includes a \$2,730,000 reserve pending bond sale to account for changes in bond market conditions at the time of the bond sale. If the \$2,730,000 reserve pending bond sale is fully expended, the remaining Clean and Safe Neighborhood Parks Bond authorization of \$6,050,000 will be \$2,136,000 less than the remaining Crane Cove project budget to be funded by the Clean and Safe Neighborhood Parks Bonds of \$8,186,000. According to Ms. Nadia Sesay, Director of Public Finance, it is unlikely that the \$2,730,000 will be fully expended under this authorization. The \$2,730,000 reserve allows for adjustment to changes in market conditions. If a portion of the \$2,730,000 is expended for any other use, such as project expenditure, it would require BOS approval.

### Recommendations

- Amend File 11-1334 to reduce the proposed appropriation for the Neighborhood Park Contingency Fund by \$990,861, from \$4,609,432 to \$3,618,561. The total appropriation for the Recreation and Park Department will be reduced from \$62,176,132 to \$61,185,271. The total not-to-exceed amount for the Clean and Safe Park Bond appropriation will be reduced from \$76,000,000 to \$75,009,139.
- Amend File 11-1345 to authorize the sale of not-to-exceed \$75,009,139 aggregate principal amount of Clean and Safe Neighborhood Parks General Obligation Bonds, consistent with the recommendation above, and approve as amended.
- Approve File 11-1334, appropriating not-to-exceed \$75,009,139 of Clean and Safe Neighborhood Parks Bonds, as amended.
- Approve File 11-1364 to release \$130,463 in Clean and Safe Neighborhood Parks Bonds previously appropriated by the Board of Supervisors and placed on Budget and Finance Committee reserve for the Pier 43 Bay Trail Link.

## MANDATE STATEMENT / BACKGROUND

### Mandate Statement

Charter Section 9.105 provides that the Board of Supervisors is authorized to approve the issuance and sale of General Obligation bonds in accordance with State law or local procedures adopted by ordinance. Charter Section 9.105 also provides that (a) amendments to the appropriation ordinance, as finally adopted, are to be adopted in the same manner as other ordinances<sup>1</sup> and (b) no amendment to the appropriation ordinance may be adopted unless the Controller certifies the availability of funds.

### Background

San Francisco voters approved the \$185 million Clean and Safe Neighborhood Parks Bonds in February 2008. The bond program was intended to:

1. Fix and improve park restrooms Citywide;
2. Eliminate serious earthquake safety risks in neighborhood and waterfront park facilities;
3. Renovate parks and playgrounds in poor physical condition;
4. Replace dilapidated playfields;
5. Repair nature trail systems in the City's parks; and
6. Attract matching community and philanthropic support.

Bond proceeds were allocated to Recreation and Parks Department and Port parks and trails, as shown in Table 1.

The City has sold \$102.9 million in 2008 Clean and Safe Neighborhood Park Bonds to date and proposes to sell \$73.3 million in February 2012, resulting in sale of \$176.2 million of the \$185 million in authorized bonds and an unsold balance of \$8.8 million, as shown in Table 2 below.

Attachment I, prepared by the Budget and Legislative Analyst, shows the allocation of bond proceeds, expenditures, and encumbrances to date. As shown in Attachment I, as of September 30, 2011, the Recreation and Park Department has spent or encumbered 48 percent of the \$87.8 million in bond proceeds and the Port has spent or encumbered 77 percent of the \$14.3 million in bond proceeds.

## DETAILS OF PROPOSED LEGISLATION

**File 11-1345:** The proposed resolution would authorize the sale of not-to-exceed \$76,000,000 aggregate principal amount of Clean and Safe Neighborhood Parks General Obligation Bonds.

The proposed resolution:

- Authorizes the Director of Public Finance to determine the sale date, interest rates, principal amount of the bonds, maturity and redemption dates, with the provision that interest rates cannot exceed 12 percent and the maturity date cannot extend after June 15, 2037;
- Provides for the execution, authentication and registration of the 2008 Clean and Safe Neighborhood Parks, Series 2012B Bonds;
- Sets the terms for transferring or redeeming the bonds;
- Provides for defeasance of the bonds;

- Requires a special Series 2012B Bond subaccount for payment of principal and interest; and a special Series 2012B project subaccount for acquisition, renovation, and construction of bond-funded projects;
- Approves the appointment of the Depository Trust Company as the securities depository, and authorizes the Treasurer to appoint fiscal and other agents;
- Approves the (a) Office Notice of Sale, which announces the date, time and terms of the competitive bond sale; (b) Notice of Intention to Sell Bonds;
- Approves the Official Statement, describing the sources and uses of funds, security for the Bonds, risk factors, and tax and other legal matters, among other information; and authorizes the Controller or Director of Public Finance to revise the Official Statement to conform to the City's Comprehensive Annual Fiscal Report (CAFR);
- Restricts use of the bond proceeds to the public purpose for which the bonds were intended;
- Approves the Continuing Disclosure Certificate, which provides certain financial information and operating data relating to the City (the "Annual Report") not later than 270 days after the end of the fiscal year and to provide notices of the occurrence of certain enumerated events, if material ;
- Authorizes City officials who have responsibility for executing documents related to the Series 2012 B Bonds, including the Controller, Director of Public Finance, and Treasurer, to modify the documents as necessary, except that the Series 2012B Bond amount cannot exceed \$76,000,000; and
- Subjects the Series 2012B Bonds to the reporting requirements of the Citizens' General Obligation Bond Oversight Committee.

**File 11-1334:** The proposed ordinance (File 11-1334) would appropriate \$76,000,000 of the bond sale proceeds, as shown in Table 3 below.

Attachment II, prepared by the Budget and Legislative Analyst, provides details of the proposed appropriation of \$76,000,000 by program, including program budget, program appropriation to date, and proposed new appropriation.

Recreation and Park Department programs and Port programs funded by the 2008 Clean and Safe Neighborhood Park Bonds will be fully funded if the Board of Supervisors approves the proposed appropriation ordinance, with the exception of the Port's Crane Cove project. According to the November 28, 2011 Bond Accountability Report, submitted by the Port to the Board of Supervisors, the Crane Cove Park project has not yet received environmental clearance consistent with the California Environmental Quality Act (CEQA), which is estimated to be completed in 2013.

**File 11-1364:** Hearing to consider the release of reserved funds in the amount of \$130,463 to fund the Port's Pier 43 Bay Trail Link Waterfront Park Project.

The Pier 43 Bay Trail Link is located north of Pier 43 in the Fisherman's Wharf area. The site consists of condemned piers and a partially closed sidewalk due to a failing seawall. The project will create new waterfront open space and a public promenade along the water's edge. The Pier 43 Bay Trail Link is funded by Port funds, grant funds, and 2008 Clean and Safe Neighborhood Park Bonds, as shown in Table 4 below.

The Pier 43 Bay Trail Link has been allocated \$7,677,800 in 2008 Clean and Safe Neighborhood Park Bonds, as follows:

- The Board of Supervisors appropriated and placed on reserve \$130,463 of 2008 Clean and Safe Neighborhood Park Bond Series 2008B for the Pier 43 Bay Trail Link in October 2008 pending approval of the final expenditure plan by the Budget and Finance Committee (File 08-1196).
- The Board of Supervisors appropriated an additional \$7,519,537 in Clean and Safe Neighborhood Parks Bond for the Pier 43 Bay Trail Link in October 2008 and in the Port's FY 2009-10 budget.

In total, the Board of Supervisors has appropriated \$7,650,000 of 2008 Clean and Safe Neighborhood Park Bonds for the Pier 43 Bay Trail Link. The balance of \$27,800 is the subject of this report (File 11-1334).

The Port completed project planning and design in January 2011. Bids for construction were advertised in February 2011 and awarded the construction contract to the lowest responsive bidder, Vortex Marine Construction, in May 2011 for a total construction contract cost of \$6,383,000. The Port issued the Notice to Proceed to the contractor in June 2011 with the substantial completion date scheduled no later than July 31, 2012.

The proposed supplemental appropriation of \$27,800 (File 11-1334) and release of reserves of \$130,463 (File 11-1364) would complete funding for the Pier 43 Bay Trail Link project.

## FISCAL IMPACTS

According to the December 12, 2011 memorandum to the Board of Supervisors from Ms. Nadia Sesay, Director of Public Finance, the not-to-exceed \$76,000,000 of Clean and Safe Neighborhood Parks Bonds are projected to have an annual interest rate of 6.0 percent over approximately 20 years. These bonds will result in estimated total debt service payments of \$125,750,823, including \$52,480,823 in interest and \$73,270,000 in principal, with estimated average annual debt service payments of \$6,287,541.

Repayment of such annual debt service will be recovered through increases to the annual Property Tax rate, which, according to the Controller's Office, averages \$0.029 per \$1,000 of assessed valuation over the anticipated 20-year term of the bonds. A single family residence with an assessed value of \$500,000, assuming a homeowner's exemption of \$7,000, would pay average annual additional Property Taxes to the City of \$14.30 per year ( $\$500,000 - \$7,000 / \$1,000 \times \$0.029$ ) if the proposed \$76,000,000 of Clean and Safe Neighborhood Parks Bonds are sold.

## POLICY ISSUES

### **The proposed resolution authorizing the sale of the Series 2012B Bonds would allow the Recreation and Park Department to waive the deadline for submitting the Bond Accountability Report**

Administrative Code Section 2.71(b) requires the Recreation and Park Department to submit a Bond Accountability Report to the Board of Supervisors 60 days prior to approval by the Board of Supervisors of the sale of any subsequent series of bonds for the same project.<sup>2</sup> The Bond

Accountability Report includes: (a) certification from an authorized representative of the Recreation and Park Department that the information in the report is correct; (b) cumulative amount of bond proceeds available and expended on the project; brief description of each project line item for which bond proceeds have been expended; (c) the amount of bond proceeds expended on each project line item; (d) identification of completed and uncompleted project line items; (e) identification of any project line item not included in a proposed expenditure report; (h) identification of any project line time

According to Ms. Taylor Emerson, Recreation and Park Department Capital and Planning Division Analyst, the Bond Accountability Report will be submitted to the Clerk of the Board of Supervisors on or before January 10, 2012.

**The proposed appropriation of Series 2012B Bonds for Recreation and Park Department projects exceeds the budget by \$990,861**

As shown in Table 2 above, the Recreation and Park Department's total prior and requested Clean and Safe Neighborhood Parks Bond authorization of \$150,005,861 is \$990,861 more than the budget of \$149,015,000. This increase of \$990,861 results from an increase in the Recreation and Park Department's Neighborhood Park Contingency Fund, offset by decreases in other Neighborhood Parks projects. The Budget and Legislative Analyst recommends reducing the requested appropriation for the Neighborhood Parks Contingency Fund by \$990,861 to conform to the Clean and Safe Neighborhood Parks budget.

**If the proposed Series 2012B Bond sale fully expends the \$2,730,000 reserve, the remaining Clean and Safe Neighborhood Parks Bond authorization will be insufficient to fund the Port's Crane Cove project**

As shown below, prior Clean and Safe Neighborhood Parks Bond proceeds' appropriations of \$102.95 million, the proposed supplemental appropriation of \$73.27 million, and the proposed reserve pending bond sale of \$2.73 million, result in \$6.05 million remaining bond authorization:

The Port's Crane Cove project is the remaining project to be funded by the Clean and Safe Neighborhood Parks Bonds. Of the total Crane Cove budget of \$9,999,250 funded by the Clean and Safe Neighborhood Parks Bonds, \$1,813,250 has been previously appropriated or will be appropriated as part this supplemental appropriation (File 11-1334) and \$8,186,000 will be appropriated through the fourth and final sale of the Clean and Safe Neighborhood Parks Bonds.

If the \$2,730,000 reserve pending bond sale is fully expended, the remaining Clean and Safe Neighborhood Parks Bond authorization of \$6,050,000 will be \$2,136,000 less than the remaining Crane Cove project budget to be funded by the Clean and Safe Neighborhood Parks Bonds of \$8,186,000. According to Ms. Sesay, it is unlikely that the \$2,730,000 will be fully

expended under this authorization. The \$2,730,000 reserve allows for adjustment to changes in market conditions. If a portion of the \$2,730,000 is expended for any other use, such as project expenditure, it would require BOS approval.

## RECOMMENDATIONS

1. Amend File 11-1334 to reduce the proposed appropriation for the Neighborhood Park Contingency Fund by \$990,861, from \$4,609,432 to \$3,618,561. The total appropriation for the Recreation and Park Department will be reduced from \$62,176,132 to \$61,185,271. The total not-to-exceed amount for the Clean and Safe Park Bond appropriation will be reduced from \$76,000,000 to \$75,009,139.
2. Amend File 11-1345 to authorize the sale of not-to-exceed \$75,009,139 aggregate principal amount of Clean and Safe Neighborhood Parks General Obligation Bonds, consistent with the recommendation above, and approve as amended.
3. Approve File 11-1334, appropriating not-to-exceed \$75,009,139 of Clean and Safe Neighborhood Parks Bonds, as amended.
4. Approve File 11-1364 to release \$130,463 in Clean and Safe Neighborhood Parks Bonds previously appropriated by the Board of Supervisors and placed on Budget and Finance Committee reserve for the Pier 43 Bay Trail Link.

The principal amount of the Bonds maturing or subject to mandatory sinking fund redemption in any year shall be in integral multiples of \$5,000. No serial Bonds may mature following the commencement of the

Adjustment of Principal Payments. The principal amounts set forth in this Official Notice of Sale reflect certain estimates of the City with respect to the likely interest rates of the winning bid and the premium contained in the winning bid. **The City reserves the right to change the**

principal payment schedule set forth above after the determination of the winning bidder, by adjusting one or more of the principal payments of the Bonds in increments of \$5,000, as determined in the sole discretion of the City. Any such adjustment of principal payments on the Bonds shall be based on the schedule of principal payments provided by the City to be used as the basis of bids for the Bonds. Any such adjustment will not change the average per Bond dollar amount of underwriter's discount. In the event of any such adjustment, no rebidding or recalculation of the bids submitted will be required or permitted and no successful bid may be withdrawn.

Redemption. (a) Optional Redemption. The Bonds maturing on or before [June 15, 2022], will not be subject to optional redemption prior to their respective stated maturity dates. The Bonds, if any, maturing on or after [June 15, 2023], are subject to optional redemption prior to their respective stated maturity dates, at the option of the City, from any source of available funds (other than mandatory sinking fund payments), as a whole or in part on any date (with the maturities to be redeemed to be determined by the City and by lot within a maturity), on or after [June 15, 2022], at the redemption price equal to the principal amount of the Bonds redeemed, together with accrued interest to the date fixed for redemption, without premium.

(b) Mandatory Redemption. Legal Opinion and Tax Matters. Upon delivery of the Bonds, Co-Bond Counsel, Goodwin Procter LLP and GCR, LLP (collectively, "Co-Bond Counsel"), will deliver an opinion for each series of the Bonds to the effect that in the opinion of such Co-Bond Counsel, based upon an analysis of existing laws, regulations, rulings, and judicial decisions and assuming, among other matters, the accuracy of certain representations and compliance with certain covenants and requirements, interest on the Bonds is excluded from gross income for federal income tax purposes under Section 103 of the Internal Revenue Code of 1986, as amended (the "Code"), and is exempt from State of California personal income taxes. In the further opinion of Co-Bond Counsel, interest on the Bonds is not a specific preference item for purposes of federal individual or corporate alternative minimum taxes, although Co-Bond Counsel observe that such interest is included in adjusted current earnings in calculating federal corporate alternative minimum taxable income. See "TAX MATTERS" in the Preliminary Official Statement.

Complete copies of the proposed form of opinions of Co-Bond Counsel is set forth in Appendix F to the Preliminary Official Statement. The approving legal opinions of Co-Bond Counsel will be furnished to the Purchaser upon delivery of the Bonds. Copies of said opinions will

be filed with The Depository Trust Company (“DTC”) and with the Treasurer of the City (the “City Treasurer”).

Goodlett Place, Room 336, San Francisco, California 94102; phone: (415) 554-5956. No bid submitted to the City is subject to withdrawal or modification by the bidder.

**All bids will be deemed to incorporate and be subject to all of the terms of this Official Notice of Sale. If the sale of the Bonds is canceled or postponed, all bids shall be rejected. No bid submitted to the City is subject to withdrawal or modification by the bidder. No bid will be accepted after the time for receiving bids. The City retains absolute discretion to determine whether any bid, sealed or electronic, is timely, legible and complete and conforms to this Official Notice of Sale. The City takes no responsibility for informing any bidder prior to the time for receiving bids that its bid is incomplete, illegible or nonconforming with this Official Notice of Sale or has not been received.**

Solely as an accommodation to bidders, electronic bids will be received exclusively through Parity in accordance with this Official Notice of Sale, but no bid will be accepted after the time specified for received bids. For further information about Parity, potential bidders may contact either of the Co-Financial Advisors or Parity, phone: (212) 849-5021.

**Warnings Regarding Electronic Bids.** Bids for the Bonds may be submitted electronically via Parity. The City will attempt to accommodate bids submitted electronically via Parity. However, the City does not endorse or encourage the use of such electronic bidding service. None of the City, the City Attorney, the Co-Financial Advisors or Co-Bond Counsel assumes any responsibility for any error contained in any bid submitted electronically or for failure of any bid to be transmitted, received or opened by the time for receiving bids, and each bidder expressly assumes the risk of, any incomplete, illegible, untimely or nonconforming bid submitted by electronic transmission by such bidder, including without limitation, by reason of garbled transmissions, mechanical failure, engaged telecommunications lines, or any other cause arising from submission by electronic transmission. The time for receiving bids will be determined by the City at the place of bid opening, and the City will not be required to accept the time kept by Parity.

**If a bidder submits an electronic bid for the Bonds through Parity, such bidder thereby agrees to the following terms and conditions: (1) if any provision in this Official Notice of Sale with respect to the Bonds conflicts with information or terms provided or required by Parity, this Official Notice of Sale, including any amendments or modifications issued through Parity,**

will control; (2) each bidder will be solely responsible for making necessary arrangements to access Parity for purposes of submitting its bid in a timely manner and in compliance with the requirements of this Official Notice of Sale; (3) the City will not have any duty or obligation to provide or assure access to Parity to any bidder, and the City will not be responsible for proper operation of, or have any liability for, any delays, interruptions or damages caused by use of Parity or any incomplete, inaccurate or untimely bid submitted by any bidder through Parity; (4) the City is permitting use of Parity as a communication mechanism, and not as an agent of the City, to facilitate the submission of electronic bids for the Bonds; Parity is acting as an independent contractor, and is not acting for or on behalf of the City; (5) the City is not responsible for ensuring or verifying bidder compliance with any procedures established by Parity; (6) the City may regard the electronic transmission of a bid through Parity (including information regarding the purchase price for the Bonds or the interest rates for any maturity of the Bonds) as though the information were submitted on the Official Bid Form and executed on the bidder's behalf by a duly authorized signatory; (7) if the bidder's bid is accepted by the City, the signed, completed and conforming Official Bid Form submitted by the bidder by facsimile transmission after the verbal award, this Official Notice of Sale and the information that is transmitted electronically through Parity will form a contract, and the bidder will be bound by the terms of such contract; and (8) information provided by Parity to bidders will form no part of any bid or of any contract between the Purchaser and the City unless that information is included in this Official Notice of Sale or the Official Bid Form.

Basis of Award. Unless all bids are rejected, the Bonds will be awarded to the responsible bidder who submits a conforming bid that represents the lowest true interest cost ("TIC") to the City. The TIC will be that nominal interest rate that, when compounded semiannually and applied to discount all payments of principal and interest payable on the Bonds to the dated date of the Bonds, results in an amount equal to the principal amount of such Bonds plus the amount of any net premium. For the purpose of calculating the TIC, mandatory sinking fund payments for any term Bonds specified by each bidder will be treated as Bonds maturing on the dates of such mandatory sinking fund payments. In the event that two or more bidders offer bids for the Bonds at the same lowest TIC, the City will determine by lot which bidder will be awarded the Bonds. Bid evaluations or rankings made by Parity are not binding on the City.

Estimate of TIC. Each bidder is requested, but not required, to supply an estimate of the TIC based upon its bid, which will be considered as informative only and not binding on either the bidder or the City.

Multiple Bids. In the event multiple bids are received from a single bidder by any means or combination thereof, the City shall accept the bid representing the lowest TIC to the City, and each bidder agrees by submitting any bid to be bound by the bid representing the lowest TIC to the City.

Good Faith Deposit. Except as otherwise provided below, a good faith deposit (the "Good Faith Deposit") in the form of a certified, treasurer's or cashier's check drawn on a solvent commercial bank or trust company in the United States of America or a financial surety bond (the "Financial Surety Bond") issued by an insurance company licensed to issue such surety bond in the State of California, in the amount of [\$3,420,000] and made payable to the order of the City and County of San Francisco, to secure the City from any loss resulting from the failure of the bidder to comply with the terms of its bid, is required for any bid to be accepted. If a check is used, it must accompany each bid. If a Financial Surety Bond is used, such surety bond must be submitted to the

In addition, at the request of Co-Bond Counsel, the Purchaser will provide in the Reoffering Price Certificate information regarding its sales of the Bonds. For the purposes of this paragraph, sales of the Bonds to the other securities brokers or dealers will not be considered sales to the general public.

Electronic Bids; Delivery of Form of Bids. If the City accepts a bidder's bid that was submitted through Parity, the successful bidder shall submit a signed, completed and conforming Official Bid Form by facsimile transmission to Anthony Ababon, fax: (415) 554-4864, as soon as practicable, but not later than one hour after the verbal award of the Bonds.

Right of Rejection and Waiver of Irregularity. The City reserves the right, in its sole discretion, to reject any and all bids for any reason and to waive any irregularity or informality in any bid which does not materially affect such bid or change the ranking of the bids.

Right to Modify or Amend. The City reserves the right to modify or amend this Official Notice of Sale in any respect, including, without limitation, increasing or decreasing the principal amount of any serial maturity or mandatory sinking fund payment for each series of the Bonds and adding or deleting serial or term maturity and mandatory sinking fund payment dates, along with corresponding principal amounts with respect thereto, for any years from 2012 through and including [2037] for the Series 2012A Bonds and the Series 2012C Bonds and for any years from 2012 through and including [2032] for the Series 2012B Bonds; provided, that any such modification or amendment will be communicated to potential bidders through the News Services not later than 1:00 p.m. (California time) on the business day preceding the date for receiving bids. Failure of any potential bidder to receive notice of any modification or amendment will not affect the sufficiency of any such notice or the legality of the sale.

Postponement or Cancellation of Sale. The City may postpone or cancel the sale of the Bonds at or prior to the time for receiving bids. Notice of such postponement or cancellation shall be given through the News Services as soon as practicable following such postponement or cancellation. If the sale is postponed, notice of a new sale date will be given through the News Services as soon as practicable following a postponement and no later than 1:00 p.m. (California time) on the business day preceding the new date for receiving bids. Failure of any potential bidder to receive notice of postponement or cancellation will not affect the sufficiency of any such notice.

Prompt Award. The Controller will take official action awarding the Bonds or rejecting all bids not later than thirty (30) hours after the time for receipt of bids, unless such time period is waived by the Purchaser.

Equal Opportunity. Pursuant to the spirit and intent of the City's Local Business Enterprise ("LBE") Ordinance, Chapter 14B of the Administrative Code of the City, the City strongly encourages the inclusion of Local Business Enterprises certified by the San Francisco Human Rights Commission in prospective bidding syndicates. ## **CLOSING PROCEDURES AND DOCUMENTS**

Delivery and Payment. **Delivery of the Bonds will be made through the facilities of DTC in New York, New York, and is presently expected to take place on or about February \_\_, 2012.** Payment for the Bonds (including any premium) must be made at the time of delivery by wire transfer in immediately available funds to the City Treasurer. Any expense for making payment in immediately available funds shall be borne by the Purchaser. The City will deliver to the Purchaser, dated as of the delivery date, the legal opinions with respect to the Bonds described in APPENDIX F – "PROPOSED FORMS OF OPINIONS OF CO-BOND COUNSEL" to the Official Statement.

Qualification for Sale. The City will furnish such information and take such action not inconsistent with law as the Purchaser may request and the City may deem necessary or appropriate to qualify the Bonds for offer and sale under the Blue Sky or other securities laws and regulations of



such states and other jurisdictions of the United States of America as may be designated by the Purchaser; provided, that the City will not execute a general or special consent to service of process or qualify to do business in connection with such qualification or determination in any jurisdiction. By submitting its bid for the Bonds, the Purchaser assumes all responsibility for qualifying the Bonds for offer and sale under the Blue Sky or other securities laws and regulations of the states and jurisdictions in which the Purchaser offers or sells the Bonds, including the payment of fees for such qualification. Under no circumstances may the Bonds be sold or offered for sale or any solicitation of an offer to buy the Bonds be made in any jurisdiction in which such sale, offer or solicitation would be unlawful under the securities laws of the jurisdiction.

No Litigation. The City will deliver a certificate stating that no litigation is pending with service of process having been accomplished, or, to the knowledge of the officer of the City executing such certificate, threatened, concerning the validity of the Bonds, the ability of the City to levy the ad valorem tax required to pay debt service on the Bonds, the corporate existence of the City, or the title to their respective offices of the officers of the City who will execute the Bonds.

Right of Cancellation. The Purchaser will have the right, at its option, to cancel this contract if the City fails to execute the Bonds and tender the same for delivery within thirty (30) days from the sale date, and in such event the Purchaser will be entitled only to the return of the Good Faith Deposit, without interest thereon.

CUSIP Numbers. It is anticipated that CUSIP numbers will be printed on the Bonds, but neither the failure to print such numbers on any Bond nor any error with respect thereto will constitute cause for a failure or refusal by the Purchaser to accept delivery of and pay for the Bonds in accordance with the terms of this contract. The Purchaser, at its sole cost, will obtain separate CUSIP numbers for each maturity of each series of the Bonds. CUSIP data are provided by Standard and Poor's, CUSIP Service Bureau, a division of The McGraw-Hill Companies, Inc. CUSIP numbers will be provided for convenience of reference only. The City will take no responsibility for the accuracy of such numbers.

California Debt and Investment Advisory Commission Fee. Pursuant to Section 8856 of the California Government Code, the Purchaser must pay to the California Debt and Investment Advisory Commission within sixty (60) days from the sale date the statutory fee for the Bonds purchased.

Official Statement. Copies of the Preliminary Official Statement with respect to the Bonds will be furnished or electronically transmitted to any potential bidder upon request to the Office of Public Finance or to either of the Co-Financial Advisors. In accordance with Rule 15c2-12 of the Securities and Exchange Commission ("Rule 15c2-12"), the City deems such Preliminary Official Statement final as of its date, except for the omission of certain information permitted by Rule 15c2-12. The contact information for the Co-Financial Advisors is set forth on the second page of this Official Notice of Sale. Within seven business days after the date of award of the Bonds, the Purchaser will be furnished with a reasonable number of copies (not to exceed 200) of the final Official Statement, without charge, for distribution in connection with the resale of the Bonds. The Purchaser must notify the City in writing within two days of the sale of the Bonds if the Purchaser requires additional copies of the Official Statement to comply with applicable regulations. The cost for such additional copies will be paid by the Purchaser requesting such copies.

By submitting a bid for the Bonds, the Purchaser agrees: (1) to disseminate to all members of the underwriting syndicate, if any, copies of the final Official Statement, including any supplements, (2) to promptly file a copy of the final Official Statement, including any supplements, with the Municipal Securities Rulemaking Board, and (3) to take any and all other actions necessary to comply with applicable Securities and Exchange Commission and Municipal Securities Rulemaking Board rules governing the offering, sale and delivery of the Bonds to the Purchaser, including without limitation, the delivery of a final Official Statement to each investor who purchases Bonds.

The form and content of the final Official Statement is within the sole discretion of the City. The Purchaser's name will not appear on the cover of the Official Statement.

Certificate Regarding Official Statement. At the time of delivery of the Bonds, the Purchaser will receive a certificate, signed by an authorized representative of the City, confirming to the Purchaser that, to the best of the knowledge of such authorized representative, the Official Statement (except for information regarding the municipal bond insurance policy, if any, and the provider thereof, DTC and its book-entry system and reoffering information, as to which no view will be expressed), as of the date of sale of the Bonds and as of the date of delivery thereof did not and does not contain any untrue statement of a material fact or omit to state a material fact necessary in order to make the statements made therein, in the light of the circumstances under which they were made, not misleading.

Continuing Disclosure. In order to assist bidders in complying with Rule 15c2-12, the City will undertake, pursuant to a Continuing Disclosure Certificate, to provide certain annual financial information, operating data and notices of the occurrence of certain events specified in such Continuing Disclosure Certificate. A description of this undertaking is set forth in the Preliminary Official Statement and will also be set forth in the final Official Statement.

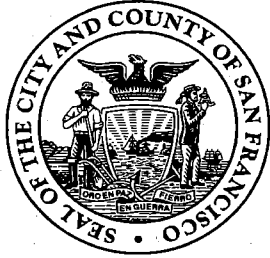
