3 **Resolution authorizing the Department of Public Library to accept and expend a grant**  
4 **in the amount of \$10,000 from the California State Library's Partnerships for Change**  
5 **Program as part of the Federal Library Services Act (LSTA) for increasing the size of**  
6 **the Asian language collection and the number of Asian interest and Asian language**  
7 **programs at the Sunset Branch Library.**

9 WHEREAS, The Public Library aims to better serve the needs of underserved  
10 communities; and,

11 WHEREAS, The California State Library supports services to diverse populations  
12 through its Partnerships for Change Program; and,

13 WHEREAS, The Sunset Branch Library plans to better serve the Asian population in  
14 their service area; and,

15 WHEREAS, The Public Library plans to increase the size of the Asian language  
16 collection, as well as the number of Asian interest and Asian language programs presented at  
17 the Sunset Branch Library; and,

18 WHEREAS, The Sunset Branch Library staff plans to develop community partnerships  
19 in order to learn about the needs of the Asian community; and,

20 WHEREAS, Potential community partners include the Chinese Newcomers Service  
21 Center, the Inner Sunset/Haight Ashbury Neighborhood Senior Center, the Vietnamese  
22 Community Center of San Francisco, NeighborNet, and San Francisco Supervisors Matt  
23 Gonzalez and Leland Yee; and,

24 WHEREAS, The Sunset Branch Library plans to provide information, programming  
25 space and resources, and publicity to the community partners; and,

1 WHEREAS, The Public Library proposes to maximize use of available grant funds on  
2 program expenditures by not including indirect costs in the budget; now, therefore, be it

3 RESOLVED, That the Public Library be authorized to accept and expend a grant in the  
4 amount of \$10,000 from the California State Library as part of the Library Services and  
5 Technology Act (LSTA) for increasing the size of the Asian language collection and the  
6 number of Asian interest and Asian language programs at the Sunset Branch Library; and be  
7 it

8 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
9 indirect costs in the grant budget.
