I am pleased to inform you that the Department of Children, Youth and Their Families has allocated \$165,000 in additional funds to your **Our Kids First Out of School Time (OST) Year-Round & Summer Learning** grant. This one-time augmentation is granted in support of the Dream Keeper Initiative to provide support for families and youth age 0-5 and resources, tools and support to prepare youth school and learning, in partnership with the African American Early Education Providers. In accepting these funds your agency also agrees to the following reporting and engagement expectations:

- Contract Management System (CMS) monthly invoices
- Referrals from the Dream Keeper Initiative
- Quarterly meetings with the Dream Keeper team
- Monthly engagement with Dream Keeper staff
