2 AUTHORIZING SETTLEMENT OF LITIGATION OF WONG REVOCABLE TRUST AKA  
3 HARVEY WONG AND HELEN K. WONG 1992 TRUST, HARVEY WONG and STEVEN  
4 WONG AND HOLSON, INC., AGAINST THE CITY AND COUNTY OF SAN FRANCISCO  
5 FOR \$75,000 AND WAIVER OF NUISANCE ABATEMENT FEES.

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the action entitled "Wong  
9 Revocable Trust AKA, et al., v. City and County of San Francisco, et al., San Francisco  
10 Superior Court No. 300-456 by 1) the payment of \$37,500 to plaintiffs Wong Revocable Trust,  
11 et al., 2) the payment of \$37,500 to cross-complainant Holson, Inc., and 3) waiver of nuisance  
12 abatement fees.

13 As consideration for this settlement, plaintiffs and cross-complainants have agreed to  
14 1) dismiss the City and County of San Francisco from this lawsuit with prejudice, 2) to fully  
15 release the City from all claims arising from the series of mudslides which gave rise to this  
16 lawsuit, and 3) to complete remedial and stabilization work on the hillside pursuant to  
17 emergency abatement orders issued by the Department of Building Inspections.




