[Changing the official sidewalk width – Golden Gate Avenue.]

Ordinance amending Ordinance No. 1061 entitled “Regulating the Width of Sidewalks” by adding thereto Section 1580 to change the official sidewalk width on the southerly side of Golden Gate Avenue between Larkin and Hyde Streets; making environmental findings and findings pursuant to the General Plan and Planning Code Section 101.1; requiring relocation, modification, or both of facilities affected by the sidewalk width change.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The Board of Supervisors adopts as its own and incorporates by reference herein as though fully set forth the Planning Department findings in its letter dated April 28, 2008 . Said letter stated the actions contemplated herein are consistent with the General Plan and in conformance with the Eight Priority Policies of Planning Code Section 101.1. A copy of said letter is in the Clerk of the Board of Supervisors File No. 080845.

Section 2. In the abovementioned letter, the Planning Department also determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seq.). Said determination is incorporated herein by reference.

Section 3. In accordance with the Department of Public Works' Order No. 177,605, a copy of which is in the Clerk of the Board of Supervisors File No. 080845 and incorporated herein by reference, Board of Supervisors Ordinance No.1061, entitled


1 "Regulating the Width of Sidewalks," a copy of which is in the Clerk of the Board of Supervisors
2 Book of General Ordinances, in effect May 11, 1910, is hereby amended by adding thereto a
3 new section to read as follows:

4 Section 1580. The official sidewalk width on the southerly side of Golden Gate Avenue shall be
5 as shown on Department of Public Works drawing O-20-647, copies of which are in the Clerk of the
6 Board of Supervisors File No. 080845.

7 Section 4. Hasting College of the Law, University of California, as is necessary as a
8 result of this Ordinance, shall make arrangements with public utility companies and City
9 Departments for the relocation, modification, or any affected public facilities. Any necessary
10 relocation, modification, or both of such facilities shall be at no cost to the City and County of
11 San Francisco.




