

1 [Report of assessment costs for sidewalk and curb repairs.]

3 **Resolution approving report of assessment costs submitted by the Director of Public**  
4 **Works for sidewalk and curb repairs ordered to be performed by said Director pursuant**  
5 **to Sections 707 and 707.1 of the Public Works Code, the costs thereof having been paid**  
6 **for out of a revolving fund, and amending Public Works Order No. 174,311 by deleting**  
7 **the assessed cost of sidewalk repairs at 449 Frederick Street.**

9       RESOLVED, That the property owner declined to request an administrative review  
10 hearing of the DPW Director's determination that said owner was obligated to repay the costs  
11 of repair to the City and County, and proper notice was provided to the owner concerning the  
12 right to a hearing. The Board of Supervisors hereby confirms that report of assessment costs  
13 described in DPW Order 174, 747, including modifications as the Board deems at necessary,  
14 be restored to the City and County revolving fund; amend Public Works Order No. 174,311  
15 heard before the Board of Supervisors on September 16, 2003 and adopted by Resolution #  
16 612-03 by deleting the assessed cost of sidewalk repairs at 449 Frederick Street (Block 1267  
17 Lot 052) in the amount of \$1590.60 from the property owners tax bill; and be it


18       FURTHER RESOLVED, That a copy of this resolution and a copy of said itemized  
19 Report of Assessment Costs confirmed by the Board shall be transmitted to the Controller and  
20 Tax Collector of the City and County, whereupon it shall be the duty of said officers to add the  
21 amount of each assessment to the next regular bill for taxes levied against each respective  
22 parcel of land, and thereafter each said amount shall be collected at the same time and in the  
23 same manner as ordinary City and County taxes are collected, and shall be subject to the  
24 same procedure under foreclosure and sale in case of delinquency as provided for ordinary  
25 taxes of the City and County; and, be it

1 FURTHER RESOLVED, That all monies received in payment of the assessments  
2 shall be credited to the revolving fund provided for in Section 706.8 of the Public  
3 Works Code, except that the portion of the assessments attributable to the cost of City  
4 Administration shall be credited to the Administrative Account of Sidewalk Repair  
5 revolving fund (Index Code 040394, Funds 02-099 Project/Work Phase 002-11).


