3 **Ordinance authorizing settlement of the lawsuit filed by Alexandra Sandoval against**
4 **the City and County of San Francisco for \$250,000; the lawsuit was filed on March 21,**
5 **2023, in Alameda County Superior Court and transferred to San Francisco Superior**
6 **Court, Case No. CGC-24-615405; entitled Alexandra Sandoval v. City and County of San**
7 **Francisco; the lawsuit involves an employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Alexandra Sandoval v. City and
12 County of San Francisco, San Francisco Superior Court, Case No. CGC-24-615405 by the
13 payment of \$250,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in Alameda County Superior Court on
15 March 21, 2023, and the following parties were named in the lawsuit: Plaintiff Alexandra
16 Sandoval (formerly Jane Doe), and defendant City and County of San Francisco.
