Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Police Code is hereby amended by amending Section 2809, to read as follows:

Sec. 2809. HOURS OF BUSINESS.

No person, firm, corporation, co-partnership or association shall engage in the business of pawnbroking or keep *his its* place of business open or transact any business therein on any day except Monday through Friday between the hours of 8:00 a.m. and 6:30 p.m., and Saturday and Sunday between the hours of 8:00 a.m. and 7:30 p.m. No person, firm, corporation, co-partnership or association shall engage in the business of pawnbroking or keep *his its* place of business open or transact business *therein* on any of the following days, *to wit: All Sundays of the year*, New Year's Day, *Washington's Birthday President's Day*, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day, and whenever any of said days shall fall on Sunday the prohibition herein contained against transacting said

pawnbroking business shall apply to the following Monday.
