2 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**
3 **and expend retroactively a grant in the amount of \$20,059 from the University of**
4 **California San Francisco (UCSF), to assist with a project entitled “Monitoring and**
5 **Evaluation Framework for Improved Health Sustainability in the Philippines;” for the**
6 **period of July 1, 2009 through November 15, 2009.**

9 WHEREAS, UCSF is the recipient of a grant award from the United States Agency for
10 International Development (USAID) and the UPecon Foundation to support the project entitled
11 “Monitoring and Evaluation Framework for Improved Health Sustainability in the Philippines;”
12 and,

13 WHEREAS, It is considered in the best interest of USAID, the UPecon Foundation,
14 UCSF, and DPH to collaborate on this project; and,

15 WHEREAS, Through this grant, UCSF has agreed to fund DPH in the amount of
16 \$20,059 for the period of July 1, 2009 through November 15, 2009; and,

17 WHEREAS, As a condition of receiving the grant funds, UCSF requires the City to
18 enter into an agreement (the “Agreement”), a copy of which is on file with the Clerk of the
19 Board of Supervisors in File No. 091176; which is hereby declared to be a part of this
20 resolution as if set forth fully herein; and,

21 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH
22 for three existing positions, Epidemiologist I (Job Class #2802) at 0.15 FTE, Health Program
23 Coordinator III (Job Class #2593) at 0.12 FTE, and Health Worker I 0.17 FTE (Job Class
24 #2585) for the period of July 1, 2009 through November 15, 2009; and,

4 therefore, be it


5 RESOLVED, That DPH is hereby authorized to accept and expend a grant in the

9 be it


10 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
11 agreement on behalf of the City; and, be it


12 FURTHER RESOLVED, That the Controller is directed to designate all positions




