

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. On March 2, 2005, Mayor Newsom established a reward fund of \$10,000 to
11 be paid to any individual or individuals supplying information leading to the arrest and
12 conviction of the person or persons responsible for the death of Jaquain Williams. During the
13 course of the investigation of the death of Jaquain Williams, a witness came forward with
14 information leading to the arrest and conviction of Don Johnson in federal district court for the
15 murder.

16 Section 2. The Controller of the City and County of San Francisco is hereby authorized
17 to draft warrants upon the Treasury of the City and County of San Francisco totaling Ten
18 Thousand Dollars (\$10,000) to be paid to the John Doe who supplied the information leading
19 to the arrest and conviction of Don Johnson for the death of Jaquain Williams.
