Be it ordained by the People of the City and County of San Francisco:


Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Angel Nguyen v. City and County of San Francisco, San Francisco Superior Court, Case No. CGC-15-549555 by the payment of \$1,350,000. The lawsuit involves an alleged personal injury at SFGH Wellness Center.

Section 2. The above-named action was filed in San Francisco Superior Court on December 22, 2015, and the following parties were named in the lawsuit: Plaintiff: Angel Nguyen, Defendants: San Francisco General Hospital; City and County of San Francisco; Regents of the University of California.
