1 AUTHORIZING THE CHIEF OF POLICE OF THE CITY AND COUNTY OF
2 SAN FRANCISCO TO ACCEPT AND EXPEND FUNDS IN THE AMOUNT OF
3 THREE HUNDRED FORTY EIGHT THOUSAND-EIGHT HUNDRED THIRTYNINE
4 DOLLARS (\$348,839.00) FOR A PROJECT DESIGNATED “INNOVATIVE LOCAL
5 LAW ENFORCEMENT AND COMMUNITY POLICING PROGRAM”

8 WHEREAS, the Chief of Police of the City and County of San Francisco desires
9 to undertake a certain project designated “Innovative Local Law Enforcement and
10 Community Policing Program” (herein after referred to as “ILLECP”) funded
11 from funds made available through the Office of Criminal Justice Planning
12 (herein after referred to as OCJP) for the reduction of juvenile delinquency
13 and crime in the Mission Corridor and Bayview Safe Haven Areas; now therefore be it

15 RESOLVED, that the Chief of Police of the City and County of San Francisco is
16 authorized to execute on behalf of the Board of Supervisors of the City and County of
17 San Francisco the attached Grant Award Agreement including any extensions,
18 amendments thereof; and be it

21 FURTHER RESOLVED, that it is agreed that any liability arising out of the
22 performance of this Grant Award Agreement, including civil court actions for damages,
23 shall be the responsibility of the grantee and the authorizing agency. The State of
24 California and OCJP disclaim responsibility for and such liability; and be it

1 FURTHER RESOLVED, that the board of Supervisors hereby waive indirect costs;
2 and be it

4 FURTHER RESOLVED, that grant funds received hereunder shall not be used to
5 supplant expenditures controlled by this body; and be it

7 FURTHER RESOLVED, that the Chief of Police of the City and County of San
8 Francisco is authorized to accept and expend funds in the amount of THREE
9 HUNDRED FORTYEIGHT THOUSAND EIGHT HUNDRED THIRTYNINE
10 DOLLARS (\$348,839.00) made available through the Office of Criminal Justice
11 Planning for the project known as "ILLECP".


