**Recommending approval of and transmitting to the Board of Supervisors a resolution to approve the Third Amendment to the Agreement for Maintenance of State Highways in San Francisco between the City and County of San Francisco and the State of California Department of Transportation (Caltrans) to include City’s maintenance and operation of additional traffic control devices on right-of-way within Caltrans jurisdiction, along State Route 280, on eastbound Alemany Boulevard at San Bruno Avenue and to authorize the Public Works Director to execute such Third Amendment.**

By this Order, the Public Works Director recommends that the Board of Supervisors approve the third amendment (“Third Amendment” or “Amendment No. 3”) to the Agreement for Maintenance of State Highways in San Francisco by and between the City and County of San Francisco and the State of California Department of Transportation, executed on July 2, 2009 and amended by Amendment No. 1 on October 27, 2011, and amended by Amendment No. 2 on October 19, 2018 (“Maintenance Agreement”), and transmits to the Board of Supervisors the proposed Third Amendment and a resolution that would approve and authorize the Director to execute the Third Amendment.

The Third Amendment would amend the Maintenance Agreement to authorize and memorialize the expansion of the City’s maintenance responsibilities of electronically operated traffic control devices to include vehicle signals installed along State Route 280, at approximately Postmile 2.05 area and on eastbound Alemany Boulevard at San Bruno Avenue, as part of the Alemany Interchange Phase II Project. The new traffic control devices are intended to improve safety of the intersection for pedestrians crossing Alemany Blvd and entering the Alemany Farmer’s Market.




