3 **Ordinance authorizing settlement of the portion of the lawsuit filed by David Cheung,**
4 **individually and dba Kwok Shing Hong against the City and County of San Francisco**
5 **for \$80,000; the lawsuit was filed on January 31, 2005 in San Francisco Superior Court,**
6 **Case No. 436930; entitled Jane Martin, et al. v. City and County of San Francisco, et al.**

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the portion of the action
9 entitled "Jane Martin, et al. v. City and County of San Francisco, et al." San Francisco
10 Superior Court, Court No. 436930, as it relates only to co-plaintiff David Cheung, individually
11 and dba Kwok Shing Hong, by the payment of \$80,000, representing the claim for diminution
12 of property value, and excluding attorney's fees, costs and interest, which will be addressed in
13 later proceedings.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiff David
16 Cheung, individually and dba Kwok Shing Hong and Defendant City and County of San
17 Francisco.
