

1 [Amending the Rules of the Board to urge Supervisors, and the Mayor, to refer to the Board of  
 2 Supervisors for public hearing all proposed ballot measures that four or more Supervisors, or  
 3 the Mayor, are planning to submit directly to the voters; urging the circulators of initiative ballot  
 measures to participate in public hearings on their measures at the Board of Supervisors.]

4 **Motion adding Rule 1.10 to the Rules of Order of the Board of Supervisors to provide**  
 5 **that Supervisors, and the Mayor, are urged to submit to the Board of Supervisors for**  
 6 **public hearing all proposed ballot measures that four or more Supervisors, or the**  
 7 **Mayor, are planning to submit directly to the voters, including general obligation or**  
 8 **revenue bond measures under sections 9.106 and 9.107 of the City Charter; and urging**  
 9 **the circulators of initiative ballot measures to participate in public hearings on their measures**  
 10 **at the Board of Supervisors.**

15 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
 16 hereby add Rule 1.10 to the Rules of Order of the Board of Supervisors to read as follows:

17 1.10. Public Hearings on Ballot Measures to be Submitted to the Voters by Four or More  
 18 Supervisors, or the Mayor, or as a result of petition circulation. City Charter sections 2.113 and  
 19 3.100 provide that four or more members of the Board of Supervisors, and the Mayor, may submit  
 20 directly to the voters declarations of policy, and any matter which the Board of Supervisors is  
 21 empowered to pass, including general obligation or revenue bond measures under sections 9.106 and  
 22 9.107 of the City Charter. Supervisors, and the Mayor, are urged to introduce any such proposed  
 23 measure at the Board of Supervisors no later than 45 days before the deadline for the submission of the  
 24 measure to the Director of Elections. The Board of Supervisors shall hold a hearing on the measure no  
 25 later than 30 days before the deadline for submission of the measure to the Director of Elections and in

1 no event later than 30 days before the deadline for submission of the measure to the Director of  
2 Elections. The sponsors of a measure may amend the measure at or after the initial hearing, provided  
3 that any such amendment must be submitted to the Board of Supervisors, and the Board of Supervisors  
4 shall hold a hearing on the amended measure, no later than 14 days before the deadline for submission  
5 of the measure to the Director of Elections. Failure of the Board of Supervisors to hold any hearing  
6 required under this section shall not preclude the sponsors from submitting the measure to the Director  
7 of Elections for submission to the voters. The Board of Supervisors further urges the circulators  
8 of petitions for initiative measures intended for, and/or scheduled for, voter consideration to  
9 work with Supervisors for the purpose of scheduling public hearings at the Board of  
10 Supervisors on the proposed initiative measures.
