3 **Motion enacting a 3% cost of living adjustment (COLA) to the base FY2017-2018**
4 **contract amount of \$2,223,739 for Budget and Legislative Analyst Services, to be**
5 **effectuated as of July 1, 2018, resulting in a new FY2018-2019 contract amount of**
6 **\$2,290,451, an increase of \$66,712; and directing the Clerk of the Board to take all**
7 **necessary administrative action to amend the contract accordingly.**

9 WHEREAS, A Request for Proposal ("RFP") was issued on May 24, 2013, and the City
10 selected Harvey M. Rose Associates, LLC, Debra A. Newman, Louie & Wong, LLP, A Joint
11 Venture, as the highest qualified scorer pursuant to the RFP; and

12 WHEREAS, The term of the contract is from January 1, 2014, to December 31, 2019,
13 with a final option to renew the contract for an additional two-year term; and

14 WHEREAS, The contract for Budget and Legislative Analyst Services allows the
15 contractor to request a COLA to their billing rates at least 60 days in advance of each January
16 1 anniversary date of the contract; and

17 WHEREAS, The Budget Analyst Joint Venture submitted a request for a 3% COLA to
18 their contract, to be effectuated as of July 1, 2018; and

19 WHEREAS, The compensation provision of the contract establishes a not to exceed
20 amount of \$2,223,739 per fiscal year beginning in FY2017-18 unless the Board of Supervisors
21 adopts a Motion enacting a COLA; now, therefore, be it

22 **MOVED, That the Board of Supervisors enact a 3% COLA to the FY2017-18 base**
23 **contract of \$2,223,739 for Budget and Legislative Analyst Services, to be effective on July 1,**
24 **2018, resulting in a new base contract in FY2018-19 of not to exceed \$2,290,451, an increase**
