Hello, please Support the Appeal File #C251098!

I urge you and the Board of Supervisors to support this appeal and overturn the Planning Commission's approval of ATT's proposed 10-story antenna structure in Diamond Heights. This massive tower would be constructed in open space at the forested property boundary of Glen Canyon and Christopher Playground as the FIRST free-standing tower over 100' tall in a San Francisco residential neighborhood next to 2 parks. All towers of this size are located in commercial or industrial areas and along 101 or 280 freeways.

This neighborhood was intentionally designed with low-profile buildings and underground wires to preserve views of the sky and natural areas. Please preserve this urban oasis and beautiful public open space.

There was misleading information sent to 4 of the 7 Planning Commissioners that were influenced by claims that ATT's FirstNet "wireless service" is required for first responders, and this tower is necessary for emergency communications. SFPD and SFFD departments do NOT require their first responders to use FirstNet, and, signal-boosting equipment exists for that purpose if and when needed.

Other local carriers provide sufficient signal strength without giant towers. The massive scale contradicts neighborhood character & four-story zoning.

False Statements in Executive Summary: "The facility is situated to avoid intrusion into public vistas and ensure harmony with existing neighborhood character."

Reality: The tower with its bulky antenna array 20 feet above trees will be highly visible from Glen Canyon, Tower over Christopher Playground, Blight skyline and tree line views from surrounding homes and streets and disrupt the visual harmony that makes the neighborhood unique.

Safety concerns and Fire Danger: Located at the top of Glen Canyon, Fire Chief Crispen described the grassy canyon as having Wildfire Urban Interface Area characteristics. Telecom facilities have caused fires in California & across the country. (e.g. ATT named defendant in 2025 Palisades Fire, Chula Vista 2021-AT&T tower fire (electrical) on school campus-smoldering steel tower collapsed on bleachers, AT&T partly responsible for 2007 Malibu Canyon Fire).

Economic Impact: Published research and local realtors confirm this tower will decrease surrounding property values AND increase homeowners insurance costs due to fire hazard, affecting rents, neighborhood financing, marketability, and shopping center customer base.

NOTE: ATT refused to consider less intrusive alternatives and would not rule out adding more antennas later. ATT changed the fuel tank from 190 to 150 gallons to avoid BAAQD requirements. Verizon and T-Mobile have excellent coverage in the area and do not require a massive tower!

Access to nature and preservation of park views are fundamental to Diamond Heights' character and residents' quality of life. This industrial electrical structure rising above trees would permanently damage what the community values most. I recommend that ATT identify an appropriate commercial/industrial location or deploy less intrusive, more modern technology that doesn't sacrifice neighborhood aesthetics, safety, and property values.

Please grant this appeal and thanks for all of your support to preserve this unique urban oasis for all of SF residents to enjoy!
