[Declaring Results of Special Election - Improvement Area No. 1 of City and County of San Francisco Special Tax District No. 2022-1 (Power Station)]

Resolution declaring the results of a special election and directing recording of notice of special tax lien for Improvement Area No. 1 of the City and County of San Francisco Special Tax District No. 2022-1 (Power Station); and determining other matters in connection therewith, as defined herein.

WHEREAS, Under Chapter 43, Article X of the San Francisco Administrative Code (as it may be amended from time to time, "Code"), which Code incorporates by reference the

Mello-Roos Community Facilities Act of 1982, as amended ("Mello-Roos Act"), this Board of

Supervisors ("Board of Supervisors") of the City and County of San Francisco ("City"), State of

San Francisco Special Tax District No. 2022-1 (Power Station), Improvement Area No. 1 and

California, has adopted a resolution entitled "Resolution of formation of City and County of

a Future Annexation Area, and determining other matters in connection therewith"

("Resolution of Formation"), ordering (i) the formation of (A) "City and County of San

Francisco Special Tax District No. 2022-1 (Power Station)" ("Special Tax District"), (B)

"Improvement Area No. 1 of the City and County of San Francisco Special Tax District No.

2022-1 (Power Station)" ("Improvement Area No. 1") and (C) a future annexation area for the

Special Tax District ("Future Annexation Area"); and (ii) authorizing the levy of a special tax on

property within Improvement Area No. 1 and preliminarily establishing an appropriations limit

for the Special Tax District; and

WHEREAS, The property in the Special Tax District is proposed for development with a project known as the Potrero Power Station ("Project"); and

WHEREAS, In the Resolution of Formation, this Board of Supervisors made certain findings under the California Environmental Quality Act ("CEQA") about the Final

Environmental Impact Report ("FEIR") for the disposition and development of the Project, and those findings are incorporated in this Resolution as if set forth in their entirety herein; and

WHEREAS, This Board of Supervisors has also adopted a resolution entitled "Resolution determining necessity to incur bonded indebtedness and other debt for the City and County of San Francisco Special Tax District No. 2022-1 (Power Station), and determining other matters in connection therewith" ("Resolution Determining Necessity"), determining (i) the necessity for the Special Tax District to incur bonded indebtedness for Improvement Area No. 1 in the maximum aggregate principal amount of \$800 million and other debt (as defined in the Mello-Roos Act) upon the security of the special tax to be levied within Improvement Area No. 1 pursuant to the Code and (ii) the necessity for the Special Tax District to incur bonded indebtedness in the maximum aggregate principal amount of \$63 million and other debt for the territory in the Special Tax District that is not in Improvement Area No. 1 ("Non-Improvement Area No. 1 Bonded Indebtedness Limit") upon the security of the special tax to be levied in such territory pursuant to the Code; and

WHEREAS, Under the provisions of the Resolution of Formation and the Resolution Necessity and pursuant to a "Resolution calling special election in Improvement Area No. 1 of the City and County of San Francisco Special Tax District No. 2022-1 (Power Station), and determining other matters in connection therewith" ("Election Resolution") adopted by this Board of Supervisors, the propositions of the levy of the special tax for Improvement Area No. 1, the establishment of the appropriations limit for the Special Tax District, and the incurring of the bonded indebtedness and other debt for Improvement Area No. 1 were submitted to the qualified electors of Improvement Area No. 1 as required by the Code; and

WHEREAS, Pursuant to the terms of the Election Resolution, which are by this reference incorporated herein, the special election has been held and the Director of Elections

of the City and County of San Francisco has on file a Canvass and Statement of Results of Election ("Canvass"), a copy of which is attached hereto as Exhibit A; and

WHEREAS, This Board of Supervisors has reviewed the Canvass, finds it appropriate and wishes to complete its proceedings for Improvement Area No. 1; now, therefore, be it

RESOLVED, That the foregoing recitals are all true and correct.

FURTHER RESOLVED, That the issues presented at the special election were the levy of a special tax within Improvement Area No. 1, the incurring of bonded indebtedness and other debt (as defined in the Mello-Roos Act) for Improvement Area No. 1, and the approval of an annual appropriations limit for the Special Tax District, all pursuant to the Resolution of Formation and the Resolution of Necessity; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby approves the Canvass and finds that it shall be a permanent part of the record of its proceedings for Improvement Area No. 1, and pursuant to the Canvass, the issues presented at the special election were approved by the qualified electors of Improvement Area No. 1 by more than two-thirds (2/3) of the votes cast at the special election; and, be it

FURTHER RESOLVED, That pursuant to the voter approval, the Special Tax District and Improvement Area No. 1 are hereby declared to be fully formed and the City has the authority to levy the special taxes in Improvement Area No. 1, the Special Tax District is authorized to incur the approved bonded indebtedness and other debt (as defined in the Mello-Roos Act) for Improvement Area No. 1 and the Special Tax District has the established appropriations limit, all as heretofore provided in these proceedings and in the Code, and it is hereby found that all prior proceedings and actions taken by this Board of Supervisors with respect to the Special Tax District, Improvement Area No. 1 and the Future Annexation Area were valid and in conformity with the Code; and, be it

FURTHER RESOLVED, That the Clerk of the Board of Supervisors is hereby directed to complete, execute and cause to be recorded in the office of the Assessor-Recorder of the City and County of San Francisco a notice of special tax lien in the form required by the Code, such recording to occur no later than fifteen (15) days following adoption by the Board of Supervisors of this Resolution; and, be it

FURTHER RESOLVED, That if any section, subsection, sentence, clause, phrase, or word of this resolution, or any application thereof to any person or circumstance, is held to be invalid or unconstitutional by a decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions or applications of this resolution, this Board of Supervisors hereby declaring that it would have passed this resolution and each and every section, subsection, sentence, clause, phrase, and word not declared invalid or unconstitutional without regard to whether any other portion of this resolution or application thereof would be subsequently declared invalid or unconstitutional; and, be it

FURTHER RESOLVED, That the Mayor, the Controller, the Director of the Office of Public Finance, the Clerk of the Board of Supervisors and any and all other officers of the City are hereby authorized, for and in the name of and on behalf of the City, to do any and all things and take any and all actions, including execution and delivery of any and all documents, assignments, certificates, requisitions, agreements, notices, consents, instruments of conveyance, warrants and documents, which they, or any of them, may deem necessary or advisable in order to effectuate the purposes of this Resolution; provided however that any such actions be solely intended to further the purposes of this Resolution, and are subject in all respects to the terms of the Resolution; and, be it

FURTHER RESOLVED, That all actions authorized and directed by this Resolution, consistent with any documents presented herein, and heretofore taken are hereby ratified, approved and confirmed by this Board of Supervisors; and, be it
