

1 [Suspension of Rule 6.13 Regarding Use of Legislative Chamber]
2 SUSPENDING RULE 6.13 OF THE RULES OF ORDER OF THE BOARD OF
3 SUPERVISORS THAT LIMITS THE USE OF THE LEGISLATIVE CHAMBER TO
4 GOVERNMENTAL PURPOSES IN ORDER TO PERMIT FILMING ACTIVITY BY WALT
5 DISNEY PICTURES IN THE CHAMBER DURING A FOUR DAY PERIOD AT THE END OF
6 APRIL 1999.

7 WHEREAS, Walt Disney Pictures requests the use of the Board of Supervisors
8 Chamber (the "Chamber") as a featured location for one of its upcoming motion pictures,
9 "Bicentennial Man," starring Robin Williams; and,

10 WHEREAS, The Board of Supervisors finds that Walt Disney Pictures' request to film
11 in the Chamber will serve a public benefit by featuring images of the carefully refurbished City
12 Hall and Chamber in a film and thereby fostering increased recognition of, and good will
13 towards, the City and its important architectural works; and

14 WHEREAS, Walt Disney Pictures requests access to and use of the Chamber for four
15 days at the end of April 1999, for two days of filming, one day for set-up and pre-lighting, and
16 one day for clean-up (collectively "Filming Activity"); now, therefore, be it

17 MOVED, That the Board of Supervisors suspends Rule 6.13 of the Rules of Order of
18 the Board of Supervisors that limits the use of the legislative chamber to governmental
19 purposes in order to permit Filming Activity by Walt Disney Pictures in the Chamber during a
20 four day period at the end of April 1999.


