WHEREAS, The California State Library Building Forward, Library Infrastructure Grant Program is the single largest investment in California's public libraries in over 20 years to address life-safety and critical maintenance needs of public library facilities throughout California, prioritized for high poverty areas of the state; and

WHEREAS, This award is intended to fund the San Francisco Public Library Seismic Moat project and Roofing Replacement project at the Main Library; and

WHEREAS, The Public Library has the legal authority and is authorized to enter into funding agreements with the State of California; and

WHEREAS, The Public Library's Chief Operating Officer, or designee is hereby authorized to sign grant documents on behalf of the Public Library; and

WHEREAS, The grant period is from the date of execution of the Agreement by both parties to June 30, 2027; and

WHEREAS, The Public Library will expend matching funds during the grant period and at the same rate as state grant funds and only on allowable costs; and

WHEREAS, The interest earned on the grant funds will be expended on allowable costs; and

WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

WHEREAS, The Department proposes to maximize use of available grant funds on program expenditures by not including indirect costs in the grant budget; now, therefore, be it RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and, be it

FURTHER RESOLVED, That the Public Library is authorized to accept and expend the California State Library Building Forward Library Facilities Improvement grant in the amount of \$6,336,363 to support the Main Library Seismic Moat and Roofing Replacement Projects; and, be it

FURTHER RESOLVED, That within 30 days of the contract being fully executed by all parties, the Director of the Public Library shall provide the final contract to the Clerk of the Board for inclusion into the official file.
