3 **Ordinance authorizing settlement of the lawsuit filed by Mitzey Davis and Leslie**
4 **Lankster against the City and County of San Francisco for \$100,000; the lawsuit was**
5 **filed on July 14, 2021, in San Francisco Superior Court, Case No. CGC-21-593819;**
6 **entitled Mitzey Davis, et al. v. City and County of San Francisco, et al.; the lawsuit**
7 **alleged personal injuries arising from a motor vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Mitzey Davis, et al. v. City and County
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-593819 by the
13 payment of \$100,000. The lawsuit involves alleged personal injuries arising from a motor
14 vehicle collision.

15 Section 2. The above-named action was filed in San Francisco Superior Court on July
16 14, 2021, and the following parties were named in the lawsuit: Plaintiffs Mitzey Davis and
17 Leslie Lankster; Defendants City and County of San Francisco, San Francisco Police
18 Department, and Michelle Liddicoet.
