Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Gwendolyn Woods v. City and County of San Francisco, et al., United States District Court, Case No. 15-cv-05666 by the payment of \$400,000. The lawsuit involves alleged civil rights violations.

Section 2. The above-named action was filed in United States District Court on December 11, 2015, and the following parties were named in the lawsuit: plaintiff: Gwendolyn Woods; defendants: City and County of San Francisco, Charles August #1119, Nicholas Cuevas #2295, Scott Phillips #1707, Winson Seto #2370, and Antonio Santos #2474.




