

1 [Appointment, Children and Families First Commission - Cesnae Crawford]

3 **Motion appointing Cesnae Crawford (residency requirement waived), term ending**  
4 **October 8, 2026, to the Children and Families First Commission.**

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby  
7 appoint the hereinafter designated person(s) to serve as member(s) of the Office of Early  
8 Childhood Community Oversight Committee, pursuant to the provisions of Administrative  
9 Code, Sections 86.1 et Seq., for the term(s) specified:

10 Cesnae Crawford (residency requirement waived), seat 7, inaugural appointment, must  
11 be a provider of family support services as described in the San Francisco County Strategic  
12 Plan, for the unexpired portion of a four-year term ending October 8, 2026; and, be it

13 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 14 1. The membership of the Children and Families First Commission has a goal to be  
15 representative of the diversity of the City and County of San Francisco.
- 16 2. Applicant Cesnae Crawford, who is not a resident of San Francisco, is a person with  
17 experience that uniquely qualifies them to serve on the Children and Families First  
18 Commission.
- 19 3. The Children and Families First Commission has attempted to fill the position, for which  
20 Cesnae Crawford was nominated, with an individual who is City a resident and who  
21 has the specific experience, skills, and qualifications, but has been unable to do so at  
22 this time. The Rules Committee has certified that Cesnae Crawford is qualified to  
23 serve on the Children and Families First Commission.

1        4. After exercising due diligence, the Board of Supervisors concludes that there is no  
2        other possible representatives who is a resident of San Francisco, who has the specific  
3        experience, skills, or qualifications possessed by this applicant, and who is willing to  
4        serve on the Children and Families First Commission at this time; and, be it  
5        FURTHER MOVED, That the Board of Supervisors waives the residency requirement  
6        for Cesnae Crawford, as is allowed in cases where no qualified City resident who is willing to  
7        serve can be found, pursuant to Charter, Section 4.101(a)(2), that otherwise requires  
8        person(s) appointed to boards, commissions, and advisory bodies established by legislative  
9        act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
