9	WHEREAS, Yuan Yuan Tan was born in Shanghai on February 14, 1976, in the year of
10	the Dragon; and
11	WHEREAS, Tan will take her final bow as a dancer with the San Francisco Ballet on
12	February 14, 2024, on her 48th birthday, performing the role of Marguerite in Frederic
13	Ashton's Marguerite and Armand; and
14	WHEREAS, At the age of 10, Tan joined the Shanghai Ballet Academy, where the
15	decision to join the ballet was made by the flip of a coin, after initial hesitation from her father;
16	and
17	WHEREAS, In 1992, San Francisco Ballet Artistic Director, Helgi Tomasson, saw Tan
18	dance at the 5th International Ballet Competition in Paris where she won the gold medal and
19	invited her to guest star for the San Francisco Ballet; and
20	WHEREAS, In 1995, Tan was named a soloist, performing the "Esmerelda" pas de
21	deux at the San Francisco Ballet gala; and
22	WHEREAS, In 1997, at the age of 20, Tan was promoted to Principal Dancer and was
23	the first Chinese and the youngest Principal Dancer at the time; and
24	WHEREAS, In 2012, Tan was appointed as the Richard C. Barker Principal Dancer;

1	WHEREAS, One of Tan's proudest achievement was dancing with the SF Ballet in		
2	Shanghai and Beijing for her 20th anniversary with the Company; and		
3	WHEREAS, Tan has won many awards for her dance, including:		
4	0	Silver medal winner of junior female division, 2nd International Ballet	
5		Competition, Helsinki, 1991.	
6	0	Named one of "20 people under the age of 40" considered heroes from Asia, in
