Not only does she support her husband and the challenges he faces on a day-to-day basis, she also has reached out to the entire Bay Area Veteran community in the activities she supports. I was honored to meet her at just one of these such activities.

I met Jenny at the Presidio Riding Club (PRC) which hosts a casual Veteran event once a month, welcoming Vets from all over the Bay Area. Jenny prepares all of the food for the event which includes a welcome morning coffee, tea, or hot chocolate with snacks, followed by lunch of a traditional American BBQ. In addition to cooking hamburgers and hotdogs, Jenny prides herself in bringing homemade chili during the cooler months and again homemade macaroni and cheese the rest of the year. In addition to the food and conversation, Vets are welcomed to enjoy the horses at PRC. Bringing some ties to the military, in 2023, the Vets who feel comfortable in a fun challenge, guide horses through mini obstacle courses, providing both a bonding experience with the horse as well as a sense of accomplishment. The majority of the Vets who attend the PRC events are living in the Tenderloin and these days are their opportunity to leave the city behind, enjoy nature and for some experience something they have never done before. Without Jenny's participation, this event would be challenging to continue, since it is in the middle of the week, when many PRC horse owners would want to volunteer but are unable to.

As a Veteran who retired at the beginning of Covid, I have had to rely on Oakland Vet Center and the VA to assist with my transition to civilian life. Having a variety of supportive organizations, allows Veterans to find the ones that work for them. Although not a combat veteran, my many deployments to various countries, have resulted in my own challenges. Finding programs like the one at PRC are how I can get a day away from the norm, experience comradery I miss from the military and eat wonderful food. I am now a volunteer at these events as a result of Jenny's welcoming and supportive personality.

When I see Jenny, I see her passion for supporting Veterans. She reaches out to each individual, shares a story or a laugh, welcoming them to the event. I have personally watched over the last few years, many of the same faces returning each month. Jenny knows them and welcomes them by name. Jenny will bring her unique background and experience as a spouse of a Veteran. I know that she will make a significant contribution to the Veteran Affairs Commission.


