14 13th Street and Townsend Street, for a term to be determined.

15 Robert Marquez, seat 6, new appointment, must represent a community-based  
16 organization or provide direct services to the Central Market Street and Tenderloin Area or in  
17 District 6, bounded on the southern side by 13th Street and Townsend Street, for a term to be  
18 determined.

19 Dina Hilliard, seat 7, new appointment, must have small business expertise and  
20 familiarity with the Central Market Street and Tenderloin Area, for a term to be determined.

21 LJ Cirillo, seat 8, new appointment, must have expertise on homelessness, transitional  
22 age youth, or supportive housing and familiarity with the Central Market Street and Tenderloin  
23 Area or in District 6, bounded on the southern side by 13th Street and Townsend Street  
24 bounded, for a term to be determined.
