4 **Examiner, to be the official newspaper of the City and County of San Francisco for all**  
5 **official advertising for Fiscal Year (FY) 2026-2027.**

6 WHEREAS, In each year, the Board of Supervisors shall designate the official  
7 newspaper of the City and County of San Francisco, pursuant to Administrative  
8 Code, Sections 2.80-1 and 2.81; now, therefore, be it

9 RESOLVED, That *Clinton Reilly Communications, dba The San Francisco*  
10 *Examiner*, a newspaper of general circulation published in the City and County of San  
11 Francisco for the dissemination of local or telegraphic news and intelligence of a general  
12 character, having a bona fide circulation of at least 50,000 copies per calendar  
13 week, and printed in the City, is hereby designated as an official newspaper of the City and  
14 County of San Francisco for the publication of all official advertising of the City and County  
15 for Fiscal Year (FY) 2026-2027; and, be it

16 FURTHER RESOLVED, That the Office of Contract Administration is hereby  
17 authorized to award *Clinton Reilly Communications, dba The San Francisco Examiner* as a  
18 sub-award to the Daily Journal, the City's official Clearinghouse contractor, in accordance with  
19 all the contracting requirements of the City and County of San Francisco; and, be it;

20 FURTHER RESOLVED, That within thirty (30) days of the Clearinghouse contract  
21 being fully-executed by all parties, the Office of Contract Administration shall provide the final  
22 contract to the Clerk of the Board for inclusion in the official file.
