

1 [Paratransit Broker Agreement]

2 APPROVING AMENDMENT NO. 9 TO THE PARATRANSIT BROKER AGREEMENT
3 BETWEEN THE CITY AND CERENIO MANAGEMENT GROUP, EXTENDING THE TERM
4 OF THE AGREEMENT THREE MONTHS, AT AN ADDITIONAL COST NOT TO EXCEED
5 \$3,752,622, FOR A TOTAL CONTRACT COST NOT TO EXCEED \$83,440,401.

6 WHEREAS, On June 17, 1991, the City entered into a Paratransit Broker Agreement
7 ("Agreement") with Cerenio Management Services ("Broker"), pursuant to which the City
8 engaged Broker to perform special transportation services, including, but not limited to,
9 subcontracting with van and taxi providers for door-to-door paratransit service for persons with
10 disabilities; and,

11 WHEREAS, Said Agreement has been extended several times and is due to terminate
12 on December 31, 1999; and,

13 WHEREAS, In order to complete the procurement process for a new paratransit broker,
14 it is necessary to extend this Agreement for an additional three months; and

15 WHEREAS, Due to additional administrative expenses and service level increases,
16 such an extension would require funding up to \$3,752,622 over and above the amount that is
17 currently authorized under the Agreement, for a total contract cost not to exceed \$83,440,401;
18 and

19 WHEREAS, The Public Transportation Commission, through Resolution No.
20 99-111, approved Amendment No. 9 to Agreement, and commended the Amendment
21 to the Board of Supervisors for approval; now, therefore, be

22 RESOLVED, That the Board of Supervisors hereby approves Amendment No. 9 to the
23 Paratransit Broker Agreement between the City and Cerenio Management Group, extending
24 the Agreement until March 31, 2000, at an additional cost not to exceed \$3,752,622 and an
25 overall contract cost not to exceed \$83,440,401.




