3 **Ordinance authorizing settlement of the lawsuit filed by Martin Collins against the City**
4 **and County of San Francisco for \$35,000; the lawsuit was filed on December 15, 2020,**
5 **in San Francisco Superior Court, Case No. CGC-20-588446; entitled Martin Collins v.**
6 **City and County of San Francisco, et al.; the lawsuit involves alleged personal injury**
7 **from a dangerous condition of public property.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Martin Collins v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-20-588446 by the
13 payment of \$35,000. The lawsuit involves alleged personal injury from a dangerous condition
14 of public property.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 December 15, 2020, and the following parties were named in the lawsuit: plaintiff Martin
17 Collins, defendant City and County of San Francisco.
