Subject: RESULTS - Outside Boards and Commissions Poll

On January 7, 2026, we surveyed each District office to determine interest in serving on the following outside Boards and Commissions. Please see the outcome below based on responses and the seniority Rule. We will work with the Rules Chair to schedule the following nominations.

The following compensated outside policy bodies have current vacancies for Board Members:

- Association of Bay Area Government (ABAG) (\$150/mtg) - 2 Members and 2 Alternates sit on this body.
 - Supervisor Chen expressed interest in Alternate Seat 3; therefore, her name will be forwarded to the Rules Committee for consideration.
- Bay Conservation and Development Commission (BCDC) (\$100/day not to exceed a combined total of four days in any one calendar month) - 1 Member sits on this body.
 - No Supervisor expressed interest in the Alternate Seat; therefore, it will remain vacant.
- California State Association of Counties (CSAC) (Reimbursement up to \$1,000) - 1 Member and 1 Alternate sit on this body.
 - Supervisor Chen expressed interest in Alternate Seat 1; therefore, her name will be forwarded to the Rules Committee for consideration.
- Golden Gate Bridge, Highway and Transportation District (GGBHTD) (\$50 per mtg, Max: \$5,000) - 4 Members sit on this body.
 - No Supervisor expressed interest in this body, therefore, it will not have San Francisco representation.
- Local Agency Formation Commission (LAFCo) (Stipend \$100/mtg) - 4 Members sit on this body. (Does not count toward the restrictions of Board Rule 6.5)
 - No Supervisor expressed interest in Member Seats 2 and 3 or Alternate Seat 4; therefore, they will be vacant.

The following non-compensated policy bodies have current vacancies for Board Members:

- Behavioral Health Commission - 1 Member sits on this body.
 - No Supervisor expressed interest in serving on this body; therefore, it will not have Board representation.
- Children and Families First Commission - 1 Member sits on this body.
 - Supervisors Chen and Sauter both expressed interest in this body. Supervisor Chen is higher in seniority, therefore; her name will be forwarded to the Rules Committee for consideration.
- ABAG General Assembly - 1 Member and 1 Alternate sit on this body.
 - No Supervisor expressed interest in serving on this body; therefore, it will not have Board representation.
- Health Authority - 1 Member sits on this body.
 - No Supervisor expressed interest in serving on this body; therefore, it will not have Board representation.
- San Francisco Int'l Airport (SFO) Community Roundtable - 1 Member and 1 Alternate sit on this body.
 - Supervisor Chen expressed interest in Member Seat 1; therefore, her name will be forwarded to the Rules Committee for consideration.
- Urban Counties of California - 1 Member sits on this body.
 - No Supervisor expressed interest in serving on this body; therefore, it will not have Board representation.

Please Note: If a seat is left vacant, we will submit a memo to the policy body affirmatively stating no members requested appointment. A vacant seat will not have San Francisco representation.
