3 **Resolution supporting and recognizing the importance of the Junior Reserve Officers'**  
4 **Training Corps program and encouraging the San Francisco Unified School District to**  
5 **continue to provide high school students the opportunity to participate and ensure the**  
6 **program is preserved as currently constituted.**

8 WHEREAS, The Junior Reserve Officers' Training Corps (JROTC) is a program  
9 sponsored by the United States Army in high schools across the country, with the mission of  
10 motivating young people to become better citizens; and

11 WHEREAS, JROTC has existed in the San Francisco Unified School District (SFUSD)  
12 for over 90 years, and SFUSD currently operates JROTC programs at six high schools -  
13 Balboa, Galileo, Lincoln, Lowell, Mission, and Washington - serving over 900 students  
14 enrolled in JROTC classes and providing Physical Education Independent Study options for  
15 over 600 students; and

16 WHEREAS, The JROTC curriculum teaches leadership, communication, self-  
17 awareness, first aid, conflict management, map reading, service learning/community service,  
18 physical training, government structure, and other topics such as finance and business, and  
19 the program fulfills various college preparatory requirements; and

20 WHEREAS, SFUSD's JROTC programs have received national honors in a variety of  
21 disciplines, cadets regularly participate in public events and collectively complete tens of  
22 thousands of community service hours each year, and cadets report viewing their JROTC  
23 community as a "second family" and as a safe environment where they feel accepted and  
24 belong; and

1           WHEREAS, JROTC does not recruit, encourage, or coerce cadets into joining the  
2 Army or any other military branch, and the cost of JROTC programs is shared equally  
3 between the Army and the local school district; and

4           WHEREAS, In 2006, the San Francisco Board of Education voted to phase out JROTC  
5 over a three-year period and later voted to delay this action, and at the November 2008  
6 election, San Francisco voters approved Proposition V, a ballot measure that declared it to be  
7 City policy that JROTC continue to be available in SFUSD high schools; and

8           WHEREAS, Following a period of limited funding, SFUSD and the Army partnered to  
9 restore full staffing at all six JROTC programs, and enrollment has grown significantly - from  
10 350 students in 2022-2023 to over 900 students today; and

11           WHEREAS, Army regulations require that every JROTC program maintain at least two  
12 instructors to remain in compliance, and adequate funding is essential to preserve these  
13 programs for San Francisco students; and

14           WHEREAS, JROTC programs require unique military credentials for instructors and  
15 face a nationwide waiting list of high schools seeking to establish programs, making it  
16 essential to maintain adequate funding to preserve San Francisco's programs; now, therefore,  
17 be it

18           RESOLVED, That the City and County of San Francisco recognizes the importance of  
19 the JROTC program and encourages SFUSD to continue to provide high school students the  
20 opportunity to participate in JROTC and to ensure the program remains fully operational, so  
21 that students may continue to choose JROTC as an academic elective and co-curricular  
22 activity; and, be it

23           FURTHER RESOLVED, That the City recognizes JROTC as a voluntary program  
24 offering benefits in character development, citizenship education, leadership training, college  
25 and career readiness, and community service; and, be it

1            FURTHER RESOLVED, That the City and County of San Francisco support the  
2 continued availability and funding of JROTC programs in local public high schools.

1. The Youth Commission negatively recommends this legislation to the full Board of Supervisors and the Mayor's Office.
2. The Youth Commission recognizes the importance of the Junior Reserve Officers' Training Corp (JROTC) and its positive impact on students.
3. The Youth Commission also recognizes the negative experiences of youth who have participated in JROTC.
4. While the leadership development in JROTC is good, if JROTC is going to be successful and protected, there needs to be direct action from the school administration and JROTC to address the issues.
5. The Commission also recommends that there be stronger language about equitable funding for JROTC staff throughout the District.

High school was frightening and unfamiliar; not only that, but I had no support system whatsoever. So much so that the stress had gotten to me. It was hard to go on with each day being as cold as the last. Numbingly repeating the vast isolation I felt. I have had mental issues in the past, so much so that I was hospitalized and held at a Crisis Stabilization Unit (CSU). I had been at one of the lowest points of my life once more. My problems persisted for long periods of time, so it only seemed logical that suicide was a way to relieve that suffering. However, JROTC had helped me out of that pit of despair. JROTC allowed me to connect with so many incredible people. Seniors, freshmen, juniors, sophomores, and even graduate students alike. I felt alive again. I had a support system and guidance for problems and questions I had about high school. I wasn't alone anymore, and that's because of JROTC.

To conclude, I ask that you all consider keeping JROTC. It brings me great sorrow that someone just like me, struggling with the burdens of life, needed a program just like JROTC, but never had the chance to get the help they needed. It is truly so incredibly beneficial to everyone. I ask you all from the bottom of my heart, please do not take such an amazing opportunity from a struggling student. Please, let that student and every future JROTC student become the best versions of themselves. With that being said, I hope my words aid you in your decision. I hope my words are taken into consideration. I thank you for your time and consideration, and hope you continue well.
