23 the General Provisions contained in the contract shown in the Grant Administration Guide;

1 FURTHER RESOLVED, That the applicant has reviewed, understands, and agrees to
2 the General Provisions contained in the contract shown in the Grant Administration Guide;
3 and, be it

4 FURTHER RESOLVED, That the Director of the Office of Economic and Workforce
5 Development is authorized to conduct all negotiations, sign and submit all documents,
6 including, but not limited to applications, agreements, amendments, and payment requests,
7 which may be necessary for the completion of the grant scope; and, be it

8 FURTHER RESOLVED, That the applicant agrees to comply with all applicable federal,
9 state and local laws, ordinances, rules, regulations, and guidelines; and, be it

10 FURTHER RESOLVED, That the Board of Supervisors for the City and County of San
11 Francisco authorizes the submittal of additional grant applications for funding from Statewide
12 Park Program Grant Funds for all available grants and this resolution shall remain in effect for
13 two (2) years.
