9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Chapter 2A, Section 2A.78 of the San Francisco Administrative Code is
11 hereby amended to read as follows:

12 **SEC. 2A.78. POLICE; INSPECTORS.** Assignment to the ranks of assistant inspector and
13 inspector in the Police Department shall be made by the Chief of Police from among those
14 members of said Department holding the ranks of sergeant , or police officer ~~or woman~~
15 ~~protective officer~~, who have qualified in the following manner; any of the aforesaid members of
16 the Police Department who has served in the Department not less than three years shall be
17 eligible to participate in a competitive examination for the rank of assistant inspector which
18 shall be administered by the Civil Service Commission. ~~Such competitive examination shall~~
19 ~~primarily pertain to matters concerning the duties of the classifications of assistant inspector and~~
20 ~~inspector. In addition to the written portion of this examination, participants shall be examined orally~~
21 ~~by a board composed of three supervisory officers having investigatory experience from those police~~
22 ~~departments in cities other than San Francisco surveyed under Charter Section A8.405, who shall be~~
23 ~~selected by the Civil Service Commission. Rating of the examination shall be a composite of grades~~
24 ~~attained in the written examination, the oral examination, and a rating for seniority of service. The~~
25 ~~written examination shall be given a weight of 75 percent and the oral examination shall be given a~~

1 ~~weight of 20 percent, and seniority of service shall be given a weight of five percent. The Civil Service~~
2 ~~Commission shall certify to the Chief of Police a list of certified candidates which shall not be less than~~
3 ~~the number of current and anticipated vacancies for a two year period as determined by the Chief of~~
4 ~~Police plus 25 percent. Said list shall rank the candidates by order of the composite grade attained in~~
5 ~~the examination. Said list shall expire every two years following adoption by the Civil Service~~
6 ~~Commission.~~ The Chief of Police shall appoint assistant inspectors to fill vacancies in the rank
7 of assistant inspector from the certified list of qualified candidates ~~by order of the grade achieved~~
8 ~~in the examination~~ as provided for under the Civil Service Rules pertaining to uniformed
9 personnel of the Police Department. ; ~~provided, however, i~~ f any member of the Department
10 appointed as an assistant inspector is a sergeant at the time of the appointment or is
11 appointed a sergeant thereafter, that member shall receive the rate of compensation attached
12 to the rank of sergeant.


13 Assistant inspectors shall serve a six-month probationary period. Appointment as
14 inspector shall not be subject to competitive examination. ~~Each inspector shall serve at the~~
15 ~~pleasure of the Chief of Police during his or her first year of service and thereafter may only be~~
16 ~~removed and returned to his or her civil service rank in the manner herein provided.~~ In case of
17 vacancy in said rank of inspector the appointment shall be made by the Chief of Police from
18 among those holding the rank of assistant inspector who have actually served as assistant
19 inspector for at least two years prior to such appointment; provided, however, that in the event
20 there are no assistant inspectors who have actually served as such for at least two years prior
21 to such appointment, the appointment may be made by the Chief of Police from among those
22 holding the rank of assistant inspector who have completed their six months' probationary
23 period prior to such appointment. The Chief of Police may, from time to time, detail members
24 of the Department for performance of duty, without change in rank, in the various units and
25 bureaus of the Department.

1 Inspectors and assistant inspectors shall have the same rights as other members of the
2 Department to take competitive examinations from their respective civil service ranks;
3 provided, however, that any member of the Department holding the rank of inspector,
4 assistant inspector or police officer may take the competitive examination for the rank of
5 sergeant. An inspector or assistant inspector guilty of any offense or violation of the rules and
6 procedures of the Police Department shall be subject to punishment as provided in Charter
7 Section A8.343; provided, however, that in addition to the punishments set forth in Section
8 A8.343, an inspector may be demoted to his or her civil service rank for any offense or
9 violation set forth in said section and after trial and hearing before the Police Commission as
10 set forth therein.


