3 **Motion directing the Office of the Budget Analyst to update its 1994 Report on the cost**  
4 **of direct services provided to the homeless population in the City and County of San**  
5 **Francisco; the completion of this update is a priority assignment.**

7 WHEREAS, In October of 1994, the Office of the Budget Analyst submitted to the  
8 Board of Supervisors a special study of programs effecting the homeless administered by the  
9 City and County of San Francisco; and,

10 WHEREAS, The primary findings showed that an estimated total of \$75,791,511 in  
11 funding for direct and indirect programs affecting the homeless in FY 1993-94; and,

12 WHEREAS, The General Fund was the revenue source for 43.7 percent of the total  
13 and other local revenue sources contributed another 7.3 percent of the funds; ~~now, therefore,~~  
14 be it and

15 WHEREAS, The term homeless includes individuals or families who lack a fixed,  
16 regular, and adequate nighttime residence and who have a primary residence in one or more  
17 of the categories outlined in the San Francisco Local Homeless Coordinating Board's  
18 Definition of Homelessness, on file with the Clerk of the Board of Supervisors in File No. 011840  
19 which is hereby declared to be a part of this resolution as if set forth fully herein; now,  
20 therefore, be it

21 MOVED, That the Office of the Budget Analyst update the 1994 report on the cost of  
22 direct services provided to the homeless population of San Francisco by completing the  
23 following:

- 24 1. Conducting a survey of City Departments to provide a description of services  
25 provided to the homeless population;


