3 **Resolution approving the expenditure of one million, six-hundred and twenty-four**
4 **thousand, nine-hundred and eighty-five dollars and nine cents (\$1,624,985.09) of**
5 **Community Development Block Grant funding and Forty Six Thousand Two hundred**
6 **and Sixty Dollars and Eighty One Cents (\$46,260.81) of Emergency Shelter Grant funds.**

8 WHEREAS, Each year the City and County of San Francisco receives Community
9 Development Block Grant ("CDBG") and Emergency Shelter Grant ("ESG") funding under
10 Title I of the Housing and Community Development Act of 1974, as amended; and,

11 WHEREAS, The Mayor's Office of Community Development ("MOCD") prepared
12 proposals for the acceptance and expenditure of CDBG funds for fiscal years 1997-2000, and
13 2003-2006, and ESG funds for fiscal year 2004/05, and the Board of Supervisors approved
14 the acceptance and expenditure of such funds in accordance with the MOCD proposals by
15 Resolution Nos. 121-98; 90-99; 349-00; 301-03; 288-04; and 295-05 for CDBG and 289-04
16 (ESG) respectively (the "Authorizing Resolutions"); and,

17 WHEREAS, MOCD has closed out grants made pursuant to the Authorizing
18 Resolutions, and as a result MOCD has recaptured CDBG funds in an amount equal to one
19 million, six-hundred and twenty-four thousand, nine-hundred and eighty-five dollars and nine
20 cents (\$1,624,985.09) and has recaptured ESG funds in an amount equal to Forty Six
21 Thousand Two hundred and Sixty Dollars and Eighty One Cents (\$46,260.81); and,

22 WHEREAS, MOCD has reprogrammed the Recaptured Funds as set forth in the
23 attached CDBG/ESG 2006 Summary; and,

24 WHEREAS, MOCD's Certifying Officer shall follow the procedural provisions of NEPA
25 to make certain that all projects and reprogrammed dollars under the Revised Funding

1 Program are performed and spent in compliance with the applicable federal provisions and
2 requirements; now, therefore, be it

3 RESOLVED, That the Board of Supervisors hereby approves the reprogramming of the
4 Recaptured Funds in accordance with the Summary attachment; and, be it

5 FURTHER RESOLVED, That MOCD is hereby authorized to enter into such
6 agreements and take such actions as are consistent with the CDBG and ESG reprogramming;
7 and, be it

8 FURTHER RESOLVED, That MOCD is hereby authorized to submit such
9 documentation and certifications as may be required by the U.S. Department of Housing and
10 Urban Development to effectuate the above reprogramming of CDBG dollars and ESG
11 dollars.


