SUSPENDING RULE 5.40 OF THE RULES OF ORDER OF THE BOARD OF SUPERVISORS TO ALLOW THE BOARD OF SUPERVISORS TO CONSIDER, WITHOUT WAITING 30 DAYS AFTER THEIR INTRODUCTION, RESOLUTIONS AUTHORIZING THE TREASURE ISLAND DEVELOPMENT AUTHORITY TO EXECUTE LEASES AND RELATED AGREEMENTS FOR HOUSING UNITS ON TREASURE ISLAND.
